Dear Chairman Mendelson:

Enclosed for consideration and approval by the Council of the District of Columbia is a bill entitled the "Law Enforcement Career Opportunity Amendment Act of 2016."

The legislation amends the Police Officer and Firefighter Cadet Programs Funding Authorization and Human Rights Act of 1977 Amendment Act of 1982, effective March 9, 1983 (D.C. Law 4-172; D.C. Official Code 5-109) to enable graduates of District high schools to join the Metropolitan Police Department (MPD) to serve as police cadets until they reach 25 years of age.

Police cadets are recent District high school graduates who are employed by MPD in civilian positions. Working about 20 hours a week, the cadets rotate through a variety of assignments – helping the MPD fulfill our mission, while providing the cadets with valuable exposure and experience within the Department. In addition to paying the cadets for their work, MPD pays for their tuition at the University of the District of Columbia. Cadets convert to career police status upon completion of their Associate Degree program and enter recruit training to become a sworn officer.

The law currently allows District high school graduates to join and serve until they reach 21 years of age. Raising the maximum age would support more District residents on a pathway to the middle class with a strong career opportunity. The program provides critical assistance to youth and young adults in their efforts to earn the 60 college credit hours required to join MPD. All applicants must meet the other standards and qualifications for becoming an MPD recruit. While MPD has funded positions for 35 cadets, and many applicants under the age of 21 for these positions, there are routinely not enough qualified applicants to fill all of the funded positions.

¹ Of these 35 positions, 18 are locally funded, 12 are funded through a Department of Employment Services grant, and five are funded by a donation.

One of MPD's long-standing goals is to recruit District residents to serve as police officers. Enacting this legislation provides another avenue for young District residents to identify and grow into a career path. I urge prompt consideration and approval of this bill.
