14	act may be cited as the "Closing of a Public Alley in Square 653, S.O. 15-26384, Act of 2018".
15	Sec. 2. (a) Pursuant to section 404 of the District of Columbia Home Rule Act, approved
16	December 24, 1973 (87 Stat. 787; D.C. Official Code § 1-204.04), and consistent with the Street
17	and Alley Closing and Acquisition Procedures Act of 1982, effective March 10, 1983 (D.C. Law
18	4-201; D.C. Official Code § 9-201.01 et seq.), the Council finds a portion of the public alley
19	system in Square 653, as shown on the Surveyor's plat filed in S.O. 15-26384, is unnecessary for
20	alley purposes and orders it closed, with title to the land to vest as shown on the Surveyor's plat.
21	(b) The approval of the Council of this alley closing is contingent upon the following:
22	(1) That title to the closed portion of the public alley system be conveyed subject
23	to a non-restrictive public access easement, as shown on the Surveyor's plat filed in S.O. 15-
24	26384, which shall run with the land and be recorded in the land records of the Recorder of

25	Deeds for the District of Columbia and shall include an agreement by the owner of the property
26	encumbered by the easement to maintain the easement area for public use;
27	(2) The completion of abandonment work for the water main located in the public
28	alley before the recordation of the alley closing plat; and
29	(3) The satisfaction of all the conditions set forth in the official file for S.O. 15-
30	26384 before the recordation of the alley-closing plat.
