Dear Chairman Mendelson:

Enclosed for consideration by the Council are the "Office of Public-Private Partnerships Delegation of Authority Clarification Emergency Amendment Act of 2018" and the accompanying "Office of Public-Private Partnerships Delegation of Authority Clarification Emergency Declaration Resolution of 2018".

The legislation would amend the Public-Private Partnership Act of 2014 ("P3 Act") and the Procurement Practices Reform Act of 2010 to allow the Office of Contracting and Procurement ("OCP") to carry out contracting activities for the Office of Public-Private Partnerships ("OP3"), at the request of OP3, under the standards of the P3 Act, retroactively to January 1, 2017.

The legislation will help ensure that OP3 and OCP can work together to procure critical large-scale capital public-private partnership projects for the District.

I urge the Council to take prompt and favorable action on this legislation.

IN THE COUNCIL OF THE DISTRICT OF COLUMBIA

A BILL

To amend, on an emergency basis, the Procurement Practices Reform Act of 2010 and the Public-Private Partnership Act of 2014 to make retroactive certain provisions added to those acts by the Office of Public-Private Partnerships Delegation of Authority Temporary Amendment Act of 2018 that allow the Office of Public-Private Partnerships to delegate its contracting authority for public-private partnership agreements to the Office of Contracting and Procurement, and to require any employee of the Office of Contracting and Procurement exercising such delegated authority to comply with provisions of the Public-Private Partnership Act of 2014 and any regulations promulgated to effectuate it.

BE IT ENACTED BY THE COUNCIL OF THE DISTRICT OF COLUMBIA, That this

act may be cited as the "Office of Public-Private Partnerships Delegation of Authority

Clarification Emergency Amendment Act of 2018".

Sec. 2. Section 201(f) of the Procurement Practices Reform Act of 2010, effective April

8, 2011 (D.C. Law 18-371; D.C. Official Code § 2-352.01(f)), as temporarily amended by the

Office of Public-Private Partnerships Delegation of Authority Temporary Amendment Act of

2018, effective November 27, 2018 (D.C. Law 22-187; 65 DCR 11410), is amended by

striking the phrase "except as provided" and inserting the phrase "except, effective January 1,

2017, as provided" in its place.

Conclusion

Funds are sufficient in the fiscal year 2019 through fiscal year 2022 budget and financial plan to implement the bill.

Background

The bill extends an emergency law¹ that the Office of Public-Private Partnerships (OP3) may delegate its contracting officer functions to the Office of Contracting and Procurement (OCP). OP3 already uses OCP for its expertise and experience in developing procurement rules and guidelines. The bill will give OP3 the ability to use OCP in the same manner as other agencies in the District. A permanent version of the bill passed final reading and will be transmitted to the Mayor.²

Financial Plan Impact

Funds are sufficient in the fiscal year 2019 through fiscal year 2022 budget and financial plan to implement the bill. No additional resources are required to implement the bill. Since OP3 is not obligated to delegate its contracting officer functions there is no cost. However, if OP3 decides to
