24	BE IT ENACTED BY THE COUNCIL OF THE DISTRICT OF COLUMBIA, That this
25	act may be cited as the "Ward 7 and Ward 8 Restaurant Incentive Program Establishment Act of

27	Sec. 2. The Small Business and Certified Business Enterprise Development and Assistance
28	Act of 2005, effective October 20, 2005 (D.C. Law 16-33; D.C. Official Code § 2-218.63), is
29	amended as follows:
30	"(a) A new subsection 2316 is added to read as follows:
31	"Sec.2316. Ward 7 and Ward 8 Restaurant Incentive Program.

64	(a) This act shall apply upon the date of inclusion of its fiscal effect in an approved
65	budget and financial plan.
66	(b) The Chief Financial Officer shall certify the date of the inclusion of the fiscal effect in
67	an approved budget and financial plan and provide notice to the Budget Director of the Council
68	of the certification.
69	(c)(1) The Budget Director shall cause the notice of the certification to be published in
70	the District of Columbia Register.
71	(2) The date of publication of the notice of the certification shall not affect the

73	Sec. 4. Fiscal impact statement.
74	The Council adopts the fiscal impact statement in the committee report as the fiscal

77	Sec. 5. Effective date.
78	This act shall take effect following approval by the Mayor (or in the event of veto by the
79	Mayor, action by the Council to override the veto), a 30-day period of congressional review as
80	provided in section 602(c)(1) of the District of Columbia Home Rule Act, approved December

81 24, 1973 (87 Stat. 813; D.C. Official Code § 1-206.02(c)(1)), and publication in the District of

82 Columbia Register.
