15	Sec. 2. Section 7 of An Act To create a Department of Corrections in the District of
16	Columbia, effective December 11, 2012 (D.C. Law 19-194; D.C. Official Code § 24-211.07), is
17	amended to read as follows:
18	"Sec. 7. Prohibition on cooperation with federal immigration agencies.
19	"(a) Absent a judicial warrant or order, issued by a federal judge appointed pursuant to
20	Article III of the United States Constitution or a federal magistrate judge appointed pursuant to
21	28 U.S.C. § 631, that authorizes a federal immigration agency to take into custody the person
22	who is the subject of such warrant or order, the District of Columbia shall not:
23	"(1) Hold an individual in the District's custody after that individual would have
24	been otherwise released, except as provided in § 24-211.02a(c)(6);
25	"(2) Except as provided in Intergovernmental Agreement No. 16-00-0016, entered
26	into between the Department of Corrections and the United States Marshals Service, provide to a

27	federal immigration agency an individual's date and time of release, location, address, or
28	criminal case information;
29	"(3) Provide to any federal immigration agency an office, booth, or any facility or
30	equipment for a generalized search of or inquiry about an individual in the District's custody;
31	"(4) Permit any federal immigration agency to interview an individual in the
32	District's custody without giving the individual an opportunity to have counsel present; or
33	"(5) Except as provided in Intergovernmental Agreement No. 16-00-0016, entered
34	into between the Department of Corrections and the United States Marshals Service, grant any
35	federal immigration agency access to a District detention facility, including St. Elizabeths
36	Hospital or a facility under the control of the Department of Corrections or the Department of
37	Youth Rehabilitation Services, for the purpose of releasing an individual into federal custody.
38	"(b) The District shall not inquire into the immigration status of an individual in its
39	custody.
40	"(c) This section shall not be construed to establish a right to counsel that does not
41	otherwise exist in law.
42	"(d) Nothing in this section shall be construed to create a private right of action.".
43	Sec. 3. Fiscal impact statement.
44	The Council adopts the fiscal impact statement of the Budget Director as the fiscal impact
45	statement required by section 4a of the General Legislative Procedures Act of 1975, approved

18	(a) This act shall take effect following approval by the Mayor (or in the event of veto by
19	the Mayor, action by the Council to override the veto), a 30-day period of congressional review
50	as provided in section 602(c)(1) of the District of Columbia Home Rule Act, approved December
51	24, 1973 (87 Stat. 813; D.C. Official Code § 1-206.02(c)(1)), and publication in the District of
52	Columbia Register.
53	(b) This act shall expire after 225 days of its having taken effect.
