Official Code § 2-352.02, I have enclosed, for consideration by the Council of the District of Columbia, a Proposed Emergency Council Resolution, an Emergency Declaration Bill, and the Council Contract Summary for the Agreement to Enter into a Long Term Subsidy Contract ("ALTSC") between the District of Columbia Housing Authority ("DCHA") and SCATTERED SITE III LLC (the "Owner"). ## A BILL

## IN THE COUNCIL OF THE DISTRICT OF COLUMBIA

To approve, on an emergency basis, the award of an Agreement to Enter into a Long Term subsidy contract for 15 years in support of the District's Local Rent Supplement Program to fund housing costs associated with affordable housing units for Contract No. 2014-LRSP-10A with SCATTERED SITE III LLC for program units at Karin House, located at 1395 Aspen Street, NW.

BE IT ENACTED, BY THE COUNCIL OF THE DISTRICT OF COLUMBIA, that this act may be cited as the "Local Rent Supplement Program Contract No. 2014-LRSP-10A Approval and Payment Authorization Emergency Act of 2020".
