Dear Chairman Mendelson:

Enclosed for consideration by the Council of the District of Columbia is proposed emergency legislation, "Contract No. DCAM-20-NC-RFP-0001D Approval and Payment Authorization Emergency Act of 2020", and corresponding emergency declaration, to approve the proposed Contract for Comprehensive City-Wide Landscaping Maintenance and Supplemental Landscaping Services, Group D, Wards 7 & 8 (DCAM-20-NC-RFP-0001D) (the "Contract") between the Department of General Services (the "Department") and RBK Construction, Inc. (the "Contractor") in the not-to-exceed ("NTE") amount of \$2,667,017.00; and, to authorize payment to the Contractor for services received and to be received under the Letter Contract and the proposed Contract.

If approved, the Contract will authorize the Contractor to continue providing all labor, materials, tools, supplies, lifts, equipment, vehicles, transportation to and from all worksites, and all else necessary to successfully provide comprehensive city-wide landscaping maintenance and supplemental landscaping services to include the mowing, mulching, pruning, leaf removal, weeding and such other related services for various District owned and operated Properties in Group D, Wards 7 & 8. Such properties include the District's public schools, municipal buildings, and parks and recreation centers, and such other locations as the Department may direct in an NTE amount of \$2,667,017.00. As the amount of the proposed Contract exceeds \$1 million, Council's approval is required for this action.

This Contract is one of five (5) firm fixed price contracts awarded under a single Request for Proposals ("RFP").

In addition to the Letter Contract and proposed Contract, attached are: (i) a contract summary; (ii) a fiscal certification; (iii) memoranda and/or certifications of legal sufficiency; (iv) a Clean Hands certification for the Contractor; (v) a proposed emergency declaration; and (vi) proposed legislation.

The Contract for Comprehensive City-Wide Landscaping Maintenance and Supplemental Landscaping Services between the Department of General Services (the "Department") and RBK Construction, Inc. has a value of \$2,467,017.00 for routine cycle services and \$200,000.00 for Supplemental Landscaping Services, for a combined Total Not-to-Exceed Contract Value of \$2,667,017.00 for the Base Period (June 1, 2020 thru May 31, 2021). FY 2020 services beginning June 1, 2020 through August 31, 2020 for routine cycle services shall not exceed \$822,339.00 and Supplemental Services shall not exceed\$100,000.00 for the Total Not-to-Exceed Letter Contract Value of \$922,339.00 are hereby verified. The remaining amount of \$182,742.00 is verified and will be funded in FY 2020. In FY 2021, \$1,561,936.00 is subject to approval in the District's Budget and Financial Plan.

We refer to the proposal submitted by RBK Construction, Inc. ("RBK" or the "Contractor") in response to the above referenced solicitation regarding *Comprehensive City-Wide Landscaping Maintenance and Supplemental Landscaping Services*. We are pleased that this work has been awarded to RBK, and if this letter is signed by RBK without modification of any kind, it will serve as a notice to proceed for the work described below. This notice to proceed is subject to the following terms:

- 1. <u>Letter Contract.</u> This is a Letter Contract between RBK Construction, Inc. and the District of Columbia Government, acting by and through its Department of General Services ("DGS" or the "Department"), and shall govern our relationship until such time as a final contract is entered into for the work described in the above referenced solicitation (the "Definitized Contract"); provided, however, that to the extent an issue is not covered in this Letter Contract, the Request for Proposals shall govern. Once the Definitized Contract is signed, this Letter Contract shall automatically terminate and merge into the Definitized Contract.
- Scope of Work. RBK is hereby authorized to proceed with providing Comprehensive City-Wide Landscaping Maintenance and Supplemental Landscaping Services in Group D,

Wards 7 & 8 as described in the Request for Proposal (RFP), Scope of Work DCAM-20-NC-RFP-0001 as amended and the Contractor's proposal dated February 20, 2020.

- 3. <u>Compensation and Not to Exceed Contract Ceiling.</u> The Contractor will be paid based on the firm, fixed rates per location as described in the Contractor's proposal dated February 20, 2020 and submitted in response to the subject RFP. The limit of this authorization is a <u>Not-To-Exceed value up to \$822,339.00 for periodic landscaping maintenance services</u> and an amount Not-to-Exceed \$100,000.00 for Supplemental Landscaping Services reimbursed on a Time and Materials basis. The total Letter Contract value shall Not-to-Exceed \$922,339.00 for all services rendered. In no event shall RBK be entitled to receive more than that amount under this Letter Contract. This not-to-exceed amount includes all costs incurred by RBK in connection with the work authorized hereby.
- 4. <u>Insurance.</u> At all times while working under this Letter Contract, the Contractor shall maintain the insurance as described in the RFP including the following insurance: (i) a comprehensive general liability policy having a policy limit of at least One Million Dollars (\$1,000,000) and (ii) workers compensation coverage at the statutory limit. All such policies shall be endorsed to add the District of Columbia, including, but not limited to, its Department of General Services, and the respective agents, employees and offices of each as additional insureds.
- 6. <u>Duration</u>. This Letter Contract shall become effective on the date fully executed by the Department's Contracting Officer on Page 4. This Letter Contract will terminate on the earlier to occur of the following: (i) the date the Definitized Contract becomes effective; or (ii) 31-August-2020. DGS reserves the right to terminate this Letter Contract, in whole or specified part, for convenience in the manner described in the Standard Contract provisions issued with the Request for Proposals.

- 8. <u>Purchase Order.</u> This Letter Contract is effective on the date this Letter Contract has been fully executed by the District. The Department's contracting group will issue a purchase order within seven (7) days of the effective date and forward a copy of that purchase order for your records. That number should be included in all future invoices and accounting records.
- 9. Indemnification. To the fullest extent permitted by law, RBK Construction Services shall indemnify and hold harmless the Department and the Department's consultants, agents and employees from and against claims, damages, losses and expenses, including but not limited to attorneys' fees, arising out of or resulting from performance of the Work, provided that such claim, damage, loss or expense is attributable to bodily injury, sickness, disease or death, or to injury to or destruction of tangible property (other than the Work itself),...but\_only\_to-the\_extent\_caused\_by-the-negligent\_acts\_or\_omissions\_of\_RBK, asubcontractor, anyone directly or indirectly employed by them or anyone for whose acts they may be liable, regardless of whether or not such claim, damage, loss or expense is caused in part by a party indemnified hereunder.
- <u>Terms & Conditions.</u> The Standard Contract Provisions for use with Specifications for District of Columbia Government Supplies and Services Contracts dated January 14, 2016 are incorporated by reference into this Letter Contract.
