14	BE IT ENACTED BY THE COUNCIL OF THE DISTRICT OF COLUMBIA, That this
15	act may be cited as the "Investigating Maternal Mortalities Temporary Amendment Act of
16	2020".

18	Act of 2000, effective October 19, 2000 (D.C. Law 13-172; D.C. Official Code § 5-1405), is

28	"(b-1) For the purposes of subsection (b) of this section, the term:
29	"(1) "Maternal mortalities" means pregnancy-associated deaths and pregnancy-
30	related deaths, as those terms are defined in section 2(4) and (5) of the Maternal Mortality
31	Review Committee Establishment Act of 2018, effective June 5, 2018 (D.C. Law 22-111; D.C.
32	Official Code § 7-671.01(4) and (5)), and deaths resulting from severe maternal morbidity.
33	"(2) "Severe maternal morbidity" means one of the following outcomes of labor
34	and delivery that results in short-term or long-term consequences to a woman's health:
35	"(A) Acute myocardial infarction;
36	"(B) Acute renal failure;
37	"(C) Adult respiratory distress syndrome;
38	"(D) Air and thrombotic embolism;
39	"(E) Amniotic fluid embolism;
40	"(F) Anesthesia complications;
41	"(G) Aneurysm;
42	"(H) Blood products transfusion;
43	"(I) Cardiac arrest/ventricular fibrillation;
44	"(J) Conversion of cardiac rhythm;
45	"(K) Disseminated intravascular coagulation;
46	"(L) Eclampsia;
47	"(M) Heart failure/arrest during surgery or procedure;

49	"(O) Puerperal cerebrovascular disorders;

64	24, 1973 (87 Stat. 813; D.C. Official Code § 1-206.02(c)(1)), and publication in the District of
65	Columbia Register.
