Pursuant to Section 451 of the District of Columbia Home Rule Act (D.C. Official Code § 1-204.51) and the Procurement Practices Reform Act (D.C. BE IT ENACTED BY THE COUNCIL OF THE DISTRICT OF COLUMBIA, that this act may be cited as the "Modifications to Human Care Agreement No. CW79329 Approval and Payment Authorization Emergency Act of 2020". Sec. 2. Pursuant to section 451 of the District of Columbia Home Rule Act. approved December 24, 1973 (87 Stat. 803; D.C. Official Code § 1-204.51), and the requirements of section 202 of the Procurement Practices Reform Act of 2010, effective April 8, 2011 (D.C. Law 18–371; D.C. Official Code § 2–352.02), the Council approves Modification Nos. 17, 18, and 19 to Human Care Agreement No. CW79329 with MBI Health Services, LLC, to provide mental health rehabilitative services, and authorizes payment in the not-to-exceed amount of \$3,101,000 for the goods and services received and to be received under these modifications for the period from September 6, 2020 through September 5, 2021.

The agency expects that closure of other contractor facilities in FY21 will result in the need for additional services with this Provider. Additionally, enrollments are expected to increase this option period.

Option Period 4 Amount: \$ 2,500,000

Explanation of difference from base period (if applicable):

(C) The goods or services to be provided, the methods of delivering goods or services, and any significant program changes reflected in the proposed contract:

The Government of the District of Columbia, Department of Behavioral Health (DBH) has a need for continued Mental Health Rehabilitation Services (MHRS) delivery networks located within the Washington, DC Metropolitan area to work in tandem with DBH by providing Consumers with Diagnostic/Assessment, Medication/Somatic, Counseling and Psychotherapy, Community Support Services and Supported Employment Services. This Human Care Agreement provides assistance for adults, youth and their families in accordance with 22A DCMR, Chapter 34. To meet this need the Contracting Officer has determined that continuing the MHRS under this Human Care Agreement is in the best interest of the District.

MBI Health Services LLC is currently providing MHRS to Consumers and has established a degree of trust within the Consumer community. Additionally, success in delivering MHRS is highly dependent upon the stability of a Contractor's network of support workers as demonstrated by weekly scheduled visits and leveraging of relationships built to minimize regression and backsliding, along with the avoidance of Consumers' de-compensation and disruption in services. Furthermore, the Contractor has an existing delivery system in place that provides for mental health treatment in a less restrictive level of care environment.

There exists a continuing need to provide MHRS to Consumers in order for DBH to meet mission essential requirements and maintain compliance with the agency's outcomes and goals. Additionally, continuity of service allows Consumers to make their own choices and reinforces efforts toward achieving high levels of trust, familiarity, compatibility, comfort, confidence and independency in their mental health recovery.

(D) The selection process, including the number of offerors, the evaluation criteria, and the evaluation results, including price, technical or quality, and past performance components:

All source selection activities were conducted prior to a letter contract award. The Contracting Officer received 28 qualified responses to the Request for Qualifications solicitation. After the evaluation of MBI Health Services' response package, the provider was determined to be qualified and eligible for a Human Care Agreement award.

The Human Care Agreement Qualification Factors included the following: Status of the DBH Mental Health Rehabilitative Services certification; corporate knowledge and skills; management plan; quality improvement plan; continuity of care and financial status. The pricing is fixed unit prices in accordance with Title 29 – Public Welfare, Chapter 52. The provider achieved successful outcomes on compliance verifications and DBH's subject matter expert review of the response package. The Contracting Officer completed a review of the agency subject matter expert's recommendation for award which resulted in the determination that the provider is qualified, responsive and responsible.

(F) The background and qualifications of the proposed contractor, including its organization, financial stability, personnel, and performance on past or current government or private sector contracts with requirements similar to those of the proposed contract:

MBI Health Services, LLC is an experienced provider of mental health services and mental health support services and has the necessary organizational structure, experience, technical skills and operational controls to perform the requirements of the Human Care Agreement. MBI Mental Health Services, LLC has demonstrated knowledge and experience working with the Consumer population and has completed the necessary DBH Provider training to support successful outcomes with mental health treatments for DBH Consumers. Furthermore, DBH has confirmed the provider has maintained a Mental Health Rehabilitative Services certification in good standing. The Contract Administrator verified that the provider's performance was satisfactory for the delivery of service under Option Year Two.

On May 14, 2020, the Contracting Officer received confirmation from the agency requesting a continuation of contractual services.

(K) The reason why the proposed change was sent to Council for approval after it is intended to take effect:

The pandemic health emergency declared by the Mayor on March 11, 2020 and subsequent Mayor's Order 2020-057 dated April 5, 2020 resulted in a FY20 budget freeze for the agency and uncertainty of funds available for FY20 and FY21. The agency's Chief Financial Officer therefore could not provide a funding certification memorandum to support timely submission of the Council Package."

(L) The reason for the proposed change:

The partial option was exercised under Modification 17 for the period September 6, 2020 through December 31, 2020. The proposed change under Modification 19 will exercise the remainder of the option and continue critical community based Mental Health Rehabilitative Services (MHRS) to include Diagnostic/Assessment, Medication/Somatic, Counseling and Psychotherapy, and Supported Employment Services in the amount of \$2,151,000.00.

(M) The legal, regulatory, or contractual authority for the proposed change:

The proposed changed is in accordance with 27 DCMR Chapter 20 section § 2008 "Exercise of Options".

No subcontracting plan is required because the contractor is a Certified Business Enterprise with the Department of Small and Local Business Development. The Certification number is LZ72772092021 with an expiration date of September 21, 2021.

It is the District's expectation that MBI Health Services, LLC shall provide Mental Health Rehabilitation Services for Consumers in their communities during Option Year Three while ensuring compliance with all terms/conditions including any required deliverables. The contractor is to maintain required District licenses/certifications along with compliance with Federal/State jurisdictional requirements for the delivery of treatment/clinical services.

(P) The amount and date of any expenditure of funds by the District pursuant to the contract prior to its submission to the Council for approval:

Modification 17-\$950,000.00 The performance period for Option Period Three began September 6, 2020.
