

## BILL NAME:

The Comprehensive Cannabis Legalization and Regulation Act of 2021.

## WHAT THIS BILL DOES:

This legislation would legalize and regulate the cultivation, production, and sale of recreational cannabis in the District.

## **IMPORTANCE OF THE BILL:**

In 2014, voters of the District overwhelmingly approved Initiative 71, which legalized the possession and cultivation of limited amounts of cannabis by residents age 21 and above. A month later, Congress included a rider in the Consolidated and Further Continuing Appropriations Act, 2015 prohibiting the District from using any funds to enact legislation taxing and regulating cannabis. This has led to a flourishing "grey market" with no regulations in place to protect consumers or the District.

To address this problem, I am pleased to introduce the Comprehensive Cannabis Legalization and Regulation Act of 2021 with my colleagues Councilmembers Allen, Bonds, Cheh, Henderson, Lewis-George, McDuffie, Pinto, and Nadeau. The Act is the culmination of over a year of work by my office and various stakeholders to draft a proposal that creates a comprehensive regulatory framework for the cultivation, production, and sale of recreational cannabis while centering reinvestment and opportunity for people and communities hit hardest by the drug war. To accomplish this, the bill includes:

- A regulatory scheme to license the cultivation, production, and retail sale of cannabis in the District. Regulations would be drafted by the renamed Alcoholic Beverage and Cannabis Administration (ABCA) in consultation with a Marijuana Advisory Committee composed of experts and community members. This would include use of a seed-to-sale tracking system to ensure that legal cannabis is not diverted into the illicit market.
- A robust social equity program to provide opportunities for entrepreneurship to individuals most impacted by the War on Drugs. At least half of all cannabis business licenses would be set aside for Social Equity Applicants, defined as residents who have been previously convicted of cannabis related offenses or have lived ten of the last twenty years in areas with high rates of poverty, unemployment, and cannabis-related arrests. Thirty percent of tax revenues from the sale of cannabis would be deposited into a Cannabis Equity and Opportunity Fund to provide loans, grants and technical assistance to these applicants.

- A community reinvestment program for communities most impacted by the War on Drugs. Fifty percent of tax revenues from the sale of cannabis would be deposited into a Community Reinvestment Program Fund. The fund would be used to provide grants to organizations addressing issues such as economic development, homeless prevention, support for returning citizens, and civil legal aid in areas with high poverty, unemployment, and gun violence.
- Automatic expungement of D.C. Code cannabis-related arrests and convictions, and opportunities for re-sentencing of cannabis-related convictions. In this bill, the Clerk of the Superior Court of the District of Columbia would search and automatically expunge any D.C. Code arrests and convictions of cannabis-related offenses. Incarcerated people would have an opportunity to have their sentence for cannabis-related offenses modified, vacated, or set aside.

This bill also includes provisions that would protect the supply of medical cannabis products for qualified patients, protect District residents who legally possess and consume cannabis so that they do not lose benefits, employment, or access to other critical resources, authorize banks to conduct business with licensees, allow for local tax deductions for licensee business expenses, and implement a robust public education campaign to inform residents of the law and responsible use of cannabis products.

This legislation will address inequities in the cannabis industry while providing for the safety and well-being of communities across the District. Previous iterations of this legislation did not go far enough to right the wrongs of the past or provide access to opportunities for our residents, particularly Black residents who have been unjustly targeted by the drug war. While we must wait for the congressional rider to be lifted before this Act could be implemented, it is my hope that with a Democratic majority in the Senate, that time will come soon.

- 218 "(i) The area has a poverty rate of at least 15%; or
- 219 "(ii) The share of households in the area that receive public assistance

  average as determined by the United States Department of Labor, for a period of at least 2

227	"(7) "DFS" means the Department of Forensic Sciences.

229	"(9) "Edible marijuana product" means any marijuana product for which the intended use
230	is oral consumption, including any type of food, drink, or pill.
231	"(10) "Electronic smoking device" shall have the same meaning as it is used in the
232	Electronic Cigarette Parity Amendment Act of 2016, effective February 18, 2017 (D.C. Law 21-
233	189; D.C. Official Code § 7-741.01(1)).
234	"(11) "FEMS" means the Fire and Emergency Medical Services Department.
235	"(12) "Finished marijuana" means usable marijuana, cannabis resin or
236	cannabis concentrate.
237	"(13) "Hemp" means a plant of the genus Cannabis and any part of the plant, whether
238	growing or not, containing a delta-9 tetrahydrocannabinol (THC) concentration of no more than
239	three-tenths of one percent $(0.3\%)$ on a dry weight basis.
240	"(14) "Laboratory agent" means an employee of an independent testing facility who
241	transports, possesses, or tests marijuana.
242	"(15) "Marijuana" means all parts of the plant from the genus Cannabis, whether growing
243	or not, with a THC concentration greater than 0.3% on a dry weight basis, the seeds thereof; the
244	resin extracted from any part of the plant; and every compound, manufacture, salt, derivative,
245	mixture, or preparation on the plant, its seeds or resin. The term does not include the mature
246	stalks of the plant, fiber produced from the stalks, oil or cake made from the seeds of the plant,
247	any other compound, manufacture, salt, derivative, mixture, or preparation of the mature stalks

(except the resin extracted therefrom) fiber, oil, cake, or the sterilized seed of the plant which isincapable of germination.

"(16) "Marijuana concentrate" means a product derived from cannabis that is produced
by extracting cannabinoids from the plant through the use of propylene glycol, glycerin, butter,
middle chain triglyceride oils, olive oil or other typical cooking fats; water, ice, or dry ice; or
butane, propane, CO2, ethanol, or isopropanol.

254 "(17) "Marijuana establishment" means a marijuana cultivator, independent testing
255 laboratory, marijuana product manufacturer, marijuana retailer, or any other type of licensed
256 marijuana-related business.

257 "(18) "Marijuana tincture" means an alcoholic extract of cannabis commonly used in the
258 production of marijuana extracts.

(19) "Member of an impact family" means an individual who has a parent, legal
guardian, child, spouse, or dependent, or was a dependent of an individual who, prior to the
effective date of this Act, was arrested for, convicted of, or adjudicated delinquent for any
offense that is eligible for expungement under this Act.

263 "(20) "Minor" means a person who is 20 years of age or younger.

264 "(21) "MPD" means the Metropolitan Police Department.

265 "(22) "OAH" means the Office of Administrative Hearings.

266 "(23) "OTR" means the Office of Tax and Revenue.

267 "(24) "Qualified social equity applicant" means social equity applicant who has been

awarded a conditional license under this act to operate a cannabis business establishment.

269 "(25) "Research project" means a discrete scientific endeavor to answer a research

270 question or a set of research questions. A research project must include the description of a

defined protocol, clearly articulated goal(s), defined methods and outputs, and a defined start andend date.

"(26) "Sale" or "sell" includes offering for sale, keeping for sale, cultivating or
manufacturing for sale, soliciting orders for sale, trafficking in, importing, exporting, bartering,
delivering for value or in any way other than by purely gratuitously transferring. Every delivery
of cannabis or a cannabis product made other than purely gratuitously shall constitute a sale.
"(27) "Seed to sale tracking system" means an inventory control system used by ABCA
and licensees under this title to track the cultivation, manufacturing, and sales of marijuana and
marijuana products.

280 "(28) "Social equity applicant" means an applicant that is a resident of the District that
281 meets one of the following criteria:

"(A) An applicant with at least 60% ownership and control by one or more
individuals who have resided for at least 10 of the preceding 20 years in a Disproportionately
Impacted Area; or

"(B) An applicant with at least 60% ownership and control by one or more
individuals who have been arrested for, convicted of, or adjudicated delinquent for any offense
that is eligible for expungement under this Act or are members of an impacted family.

288 "(29) "Straw ownership" is nominal ownership without the attendant benefits and risks of 289 genuine ownership, where someone, often for a fee, allows themselves to be named on 290 documents or purports in writing to be an owner, in whole or in part, to the government for the 291 sake of satisfying a regulatory requirement. Straw ownership for the sake of satisfying a 292 regulatory requirement is a species of fraud and may be used to submit a false claim.

293 "(30) "Sweat equity contributions" are non-monetary investments that founders, owners,

294 and employees contribute to a business venture, through which they obtain shares of ownership

295 as specified in a service agreement.

296 "(31) "THC" means tetrahydrocannabinol.".

297 "§ 25-2102. Sale of cannabis or cannabis products without a license prohibited.

298 "(a) No person shall sell cannabis or cannabis products in the District without

299 having first obtained an appropriate license as required by this title.

300 (b) No cultivator or manufacturer located within the District shall offer marijuana or any 301 marijuana products for sale to, or solicit orders for the sale of marijuana or marijuana products 302 from, any person not licensed under this title.

303 "(c) This Act shall not be construed to regulate or include hemp plants and hemp 304

products as the Agriculture Improvement Act of 2018 legalized industrial hemp under

305 Federal law [Public Law No.: 115-334].

306 "(d) It shall be unlawful to give marijuana or marijuana products for free to a person

307 in exchange for their purchasing another item or service, making a donation, engaging in

308 advocacy, joining a club or organization, or paying a cover charge for a party or event. Such a

309 transaction shall constitute a sale of marijuana and shall be unlawful without a license.".

310 "§ 25-2103. Authority to grant licenses.

311 "(a) The Board may issue licenses to persons who meet the requirements set forth 312 in this title.

313 "(b) All marijuana licenses issued under this title shall be valid for a term of 3 314 years and may be renewed upon completion of the renewal procedures established by the 315 Board and payment of the required fees.

316 "(c) A license to sell cannabis or cannabis products can only be granted by the
317 Board upon completion of the application and review process as contained in this title.

318 "(d) A license for a marijuana establishment shall describe the location of where the319 rights of the license are to be exercised.

320 "(e) The Board, in issuing licenses, may require that certain conditions be met if it 321 determines that the inclusion of conditions will be in the best interest of the locality, section, or 322 portion of the District where the licensed establishment is to be located. Official Code § 25-3001 shall be deposited into the Fund 328 without regard to fiscal year limitation pursuant to an act of Congress, and used solely to pay the 329 costs of operating and maintaining the Fund and for the purposes stated in subsection (c) of this 330 section. 365 "(4) Provide staff, administration, and related support required to administer this366 section;

367 "(5) Establish application, notification, contract, and other forms, procedures, or
 368 rules deemed necessary and appropriate; and

369 "(6) Utilize vendors or contract work to carry out the purposes of this act.
370 "(c) Grants made under this section shall be awarded on a competitive and annual basis.
371 Grants made under this Section shall further and promote the goals of this act, including the
372 promotion of Social Equity Applicants, job training and workforce development, and technical
373 assistance to Social Equity Applicants.

374 "(d) Loans made under this section shall be in such principal amount and form and 375 contain such terms and provisions with respect to security, insurance, reporting, delinquency 376 charges, default remedies, and other matters as ABCA shall determine appropriate to protect the 377 public interest and to be consistent with the purposes of this section. The terms and provisions 378 may be less than required for similar loans not covered by this section.

379 "(e) Beginning January 1, 2023 and each year thereafter, ABCA shall annually report to
380 the Council on the outcomes and effectiveness of this section that shall include the following:

381	"(1) The number of persons or businesses receiving financial assistance under this
382	section;
383	"(2) The amount in financial assistance awarded in the aggregate, in addition to
384	the number of loans made that are outstanding and the number of grants awarded;
385	"(3) The location of the project engaged in by the person or business; and
386	"(4) If applicable, the number of new jobs and other forms of economic output
387	created as a result of financial assistance.
388	"(f) The Board shall include engagement with individuals with limited English
389	proficiency as part of its outreach provided or targeted to attract and support Social Equity
390	Applicants.".
391	"\$ 25-2107. Transfer of license awarded to a social equity applicant.
392	"(a) In the event a Social Equity Applicant seeks to transfer, sell, or grant a cannabis
393	business establishment license within 5 years after it was issued to a person or entity that does
394	not qualify as a Social Equity Applicant, the transfer agreement shall require the new license
395	holder to pay the Cannabis Equity and Opportunity Fund an amount equal to:
396	"(1) Any fees that were waived by the Board based on the applicant's status as a
397	Social Equity Applicant, if applicable;
398	"(2) Any outstanding amount owed by the Qualified Social Equity Applicant for a
399	loan through the Cannabis Equity and Opportunity Fund, if applicable; and
400	"(3) The full amount of any grants that the Qualified Social Equity Applicant
401	received from ABCA, if applicable.
402	"(b) In cases where a Social Equity Applicant seeks to transfer, sell, or grant a cannabis
403	business establishment license to a non-Social Equity Applicant, the Board shall consider

404 whether the transfer would undermine the set-aside thresholds established in D.C. Official Code405 § 25-2106 when determining approval of said transfer.

406 "(c) Transfers of cannabis business establishment licenses awarded to a Social Equity
407 Applicant are subject to all other provisions of this Act, and rules regarding transfers.".

408 "§ 25-2108. Community reinvestment program fund.

409 "(a) There is established a Community Reinvestment Program Fund ("Fund") which shall 410 be separate from the General Fund of the District of Columbia. 50% of monies obtained pursuant 411 to D.C. Official Code § 25-3001 shall be deposited into the Fund without regard to fiscal year 412 limitation pursuant to an act of Congress, and used solely to pay the costs of operating and 413 maintaining the Fund and for the purposes stated in subsection (b) of this section. All funds, 414 interest, and other amounts deposited into the Fund shall not be transferred or revert to the 415 General Fund of the District of Columbia at the end of any fiscal year or at any other time but 416 shall continually be available for the uses and purposes set forth in this section, subject to 417 authorization by Congress in an appropriations act.

418 "(b) Monies from the Fund shall be used to provide grants to community-based
419 organizations that address economic development, mental health treatment, substance use
420 disorder treatment, non-law enforcement violence prevention services, homeless prevention
421 services, re-entry services, youth development, and civil legal aid in eligible program areas as
422 determined by ABCA in subsection (c).

423 "(c)(1) Within 180 days after the effective date of this act, ABCA and the Deputy Mayor
424 for Economic Development shall identify areas in the District that are eligible to participate in
425 the Community Reinvestment Program. Eligibility shall be determined by an analysis of data that

finds that the area is high need, underserved, disproportionately impacted by economicdisinvestment, and experiences high levels of gun violence, unemployment, or child poverty.

428 "(2) ABCA and the Deputy Mayor for Economic Development shall send to the
429 Council and make publicly available its analysis and identification of eligible areas in the
430 District. ABCA shall recalculate the eligibility data every 4 years.

431 "(d) There is established a Community Reinvestment Program Board (CRPB) that is
432 responsible for the selection of grantees eligible under subsections (b) and (c). The Board shall
433 be under the Deputy Mayor for Economic Development, who shall work in consultation with
434 ABCA. The CRPB shall be constituted within 180 days after the eligible areas have been
435 designated. Members shall be appointed by the Mayor, with the advice and consent of the
436 Council pursuant to section 2(a) of the Confirmation Act of 1978, effective March 3, 1979 (D.C.
437 Law 2-142; D.C. Official Code § 1-523.01(a)), and shall include:

438 "(1) Three members of community-based organizations that provide services such
439 as job placement and training, educational services, workforce development, and wealth-building
440 in marginalized communities.

441 "(2) Three persons who have been previously incarcerated in the District; and
442 "(3) Three persons from areas eligible for grant funding under the Community
443 Reinvestment Program.

444 "(e) The Board shall also include the following ex-officio members:

445 "(4) The Director of Department of Employment Services or his or her designee;
446 "(5) The Director of the Office of Neighborhood Safety and Engagement or his or
447 her designee; and

448

"(6) The Director of the Department of Health or his or her designee.

449	"(f) A non-ex-officio member shall disclose any conflicts of interest and recuse him or
450	herself from the discussion or consideration of any grant application or program recommendation
451	where a conflict of interest exists.
452	"(f) Within 12 months after the effective date of this Act, the CRPB shall:
453	"(1) Develop a process to solicit community input on the types of programs and
454	grant activities that should be a priority within eligible areas;
455	"(2) Develop a process to solicit applications from eligible areas;
456	"(3) Identify resources sufficient to support the full administration and evaluation
457	of the program, including building and sustaining core program capacity;
458	"(4) Review grant applications and proposed agreements and approve the
459	distribution of resources;
460	"(5) Develop a performance measurement system that focuses on positive
461	outcomes;
462	"(6) Develop a process to support ongoing monitoring and evaluation;
463	"(7) Deliver an annual report to the Mayor and the Council on the distribution of
464	grant funding, performance measurement outcomes, grantee activities, and any other information
465	deemed necessary.
466	(g) The Fund shall be subject to annual audits by the Office of the Chief Financial
467	Officer, which shall be submitted to Council no later than February 1 of each year. The audit
468	shall examine and determine compliance with all applicable laws, rules, and regulations. The
469	audit reports shall be submitted to the Council and the Mayor.".
470	"§ 25-2109. Incentives for the production of medical marijuana products.

471 "The Board is authorized, through rulemaking, to develop and provide incentives for
472 licensees to produce an adequate supply of medical marijuana and medical marijuana products
473 for qualified patients. Incentives may include the lowering of application and license fees,
474 expedited application and license review, or other financial or non-financial incentives for
475 licensees who will dedicate a percentage of his or her marijuana cultivation, manufacturing, or
476 retail sale to the cultivation, manufacturing, or sale of medical marijuana or medical marijuana
477 products.".

478 (e) A new Chapter 22 is added to read as follows:

479

480

"§ 25-2201. Cultivation licenses.

481 "(a) A cultivation license shall authorize the licensee to grow and produce medicinal
482 and/or recreational marijuana for sale and delivery at wholesale directly to manufacturers, testing
483 facilities, and retailers.

CHAPTER 22. CLASSIFICATION OF LICENSES.

484 "(b) The holder of a cultivation license shall not be permitted to sell or deliver cannabis485 or cannabis products directly to the consumer.

486 "(c) Cannabis or cannabis products shall not be consumed, smoked, applied, or487 vaped on the licensed premises.

488 "(d) The holder of a cultivation license shall provide the Board with the method of 489 disposal used when a testing facility determines that pesticides, mold, or mildew exceed 490 permitted levels or that the cannabis plants are otherwise not suitable for retail

491 distribution.

492 "(e) The Board may create tiers or types of cultivation licenses that are based on square493 footage, plant count, or annual sales.".

"§ 25-2202. Manufacturer licenses.

495 "(a) A manufacturer's license shall authorize the licensee to process, package, and label
496 medicinal and/or recreational marijuana and medicinal and/or recreational marijuana products for
497 sale and delivery at wholesale directly to testing facilities and retailers.

- 498 "(b) The holder of a manufacturer's license shall not be permitted to sell or deliver any
- 499 cannabis or cannabis products directly to the consumer.
- 500 "(c) Cannabis or cannabis products shall not be consumed, smoked, applied, or
- 501 vaped on the licensed premises.".
- 502 "§ 25-2203. Marijuana microbusiness licenses.

503 "(a)(1) A marijuana microbusiness license shall authorize the licensee to cultivate,

504 manufacture, and sell at retail medical and/or recreational marijuana and medical and/or

505 recreational marijuana products.

- 506 "(2) The holder of a microbusiness license shall be permitted to sell any cannabis507 or cannabis products to off-premises retailers for sale.
- 508 "(b) A marijuana microbusiness shall not have a total canopy of more than 1,500 square
  509 feet for the cultivation of medical and/or recreational marijuana.

510 "(c) The holder of a marijuana microbusiness license shall comply with all applicable
511 laws and regulations regarding cultivation, manufacturing, and sale of marijuana and marijuana
512 products.

- 513 "(d) Medical marijuana and medical marijuana products must be stored in a manner that 514 separates these products from recreational marijuana or recreational marijuana products.
- 515 "(e) Cannabis or cannabis products shall not be opened, or the contents consumed,
- 516 smoked, applied, or vaped, at licensed establishments.".

"§ 25-2204. Off-Premises retailer's licenses.

518 "(a)(1) An off-premises retailer's license shall authorize the licensee to sell medical 519 and/or recreational marijuana, and medical and/or recreational marijuana products received from 520 a licensed cultivator, or manufacturer, at retail directly to qualifying patients and caregivers, or 521 customers.

522 "(2) In order to sell medical marijuana or medical marijuana products, an off-523 premises retailer must:

524 "(A) Register in a form and manner specified by the Board; and
525 "(B) Store and display medical marijuana and medical marijuana products

in a manner that separates these products from recreational marijuana or recreational marijuanaproducts.

528 "(b) Cannabis or cannabis products shall not be opened, or the contents consumed,
529 smoked, applied, or vaped, at licensed establishments.

530 "(c) The holder of an off-premises retailer's license shall not be permitted to sell any531 cannabis or cannabis products to other licensees for resale.

532 "(d) The Board shall propose regulations creating new off-premises license categories, 533 fees, and permitted hours of sales and operation within 18 months of the effective date of the 534 Act. The Board shall consider, but not be limited to, examining whether and under what 535 conditions off-premises retail sales of marijuana and marijuana products should be permitted at 536 full-service grocery stores as defined under § 25-101(22A), farmer's markets, hotels, and events 537 in which the licensee has been approved for a one-day substantial change as defined by 538 regulation.".

539 "§ 25-2205. On-premises retailer's licenses.

540 "(a) The Board shall propose regulations creating new on-premises license categories,
541 fees, and permitted hours of sales and operation within 18 months of the effective date of the
542 Act. The Board shall consider, but not be limited to, safe use centers, creative arts venues, hotels,
543 social clubs, restaurants, and temporary events.

544 "(b) Notwithstanding any other District law, the Board shall consider whether the on-545 premises consumption of edibles, vaping, or smoking cannabis should be permitted. In no event546 shall the vaping or smoking of cannabis be permitted on outdoor public space, federally owned547 land or buildings, or space owned or leased by the facility, at street level, or adjacent to the street548 or sidewalk. As part of its review, the Board shall also consider whether hookah lounges offering549 cannabis products should be permitted.

550 "(c) The Board shall consult with DOH and the FEMS in preparing regulations551 pursuant to this section.".

552 "§ 25-2206. Testing Facility licenses.

553 "(a) A testing facility license shall authorize the licensee to test medical and recreational 554 marijuana plants and medicinal and recreational manufactured products for contaminants and 555 potency.

556 "(b) The holder of a testing facility license shall be permitted to transport samples to and557 from another licensee.

558 "(c)(1) The Board, in coordination with the DFS, shall establish certification and testing 559 protocols for the sampling, testing, and analysis of medical and recreational marijuana and 560 medical and recreational marijuana products.

561 "(2) Certification protocols shall include, at a minimum, an analysis of a testing
562 facility's standard operating procedures and facilities and equipment.

563 "(d) DFS may obtain samples sufficient to perform tests and may conduct inspections of
564 licensees' premises in order to effect the purposes of this title.".

565 "§ 25-2206. Research and development facility licenses.

566 "(a) A research and development facility license shall authorize the licensee to cultivate
567 or possess medical marijuana and medical marijuana products for the use in research projects
568 only.

569 "(b) A licensed cultivation, manufacturer, or microbusiness may transfer medical
570 marijuana or medical marijuana products to a research and development facility for use in
571 research projects only.

572 "(c) At a minimum, Board approved regulations for research and development facilities 573 shall include a description of authorized research activities for research and development 574 facilities, establish thresholds for the number of medical cannabis plants that a research and 575 development facility may possess at any one time, define procedures for medicinal cultivators or 576 manufacturers to transfer medical marijuana and medical marijuana products to a research and 577 development facility, and establish minimum standards for research involving animal or human 578 subjects, with minimum standards for human subject research conforming to the Federal Policy 579 for the Protection of Human Subjects.".

580 § 25-2207. Laboratory agent registration.

581 "(a) A laboratory agent volunteering or working at a licensed testing facility shall register
582 with the ABCA prior to starting work or volunteering.

583 "(b) The holder of a testing facility license may apply to ABCA for a registration card for 584 each affiliated laboratory agent by submitting at a minimum the name, address, and date of birth 585 of the laboratory agent.

586 "(c) The holder of a testing facility license shall notify ABCA within one business day if 587 a laboratory agent ceases to be associated with the laboratory, and the laboratory agent's 588 registration card shall be immediately revoked by ABCA.

589 "(d) A registered laboratory agent shall not be subject to arrest, prosecution, civil 590 penalty, sanctions, or disqualifications under District law, and shall not be subject to seizure or 591 forfeiture of assets under District law for actions taken under the authority of a licensed testing 592 facility and consistent with applicable District laws, regulations, and issuances, including 593 possessing, processing, storing, transferring or testing marijuana within the District of Columbia, 594 provided the registered laboratory agent presents his or her registration card to MPD, any other 595 law enforcement official, or an ABCA investigator or DFS inspector who questions the 596 laboratory agent concerning their marijuana-related activities.

597 "(e) The fee for a laboratory agent registration card shall be determined by rulemaking by598 the Board.

599 "§ 25-2208. Delivery endorsement.

600 "(a) The holder of a marijuana microbusiness or off-premises retailer's license shall
601 obtain a delivery endorsement from the Board to be eligible to deliver applicable cannabis or
602 cannabis products directly to District resident's homes.

603 "(b) The Board may issue rules providing for delivery endorsements by a contractor of a 604 marijuana microbusiness or off-premises retailer, provided that the contractor is approved by the 605 Board, is not a for-hire vehicle service, and does not use vehicles with markings relating to 606 cannabis.

607 "(c) There shall be no additional fee for a delivery endorsement.".

608 (f) A new Chapter 23 is added to read as follows:

609	CHAPTER 23. LICENSEE AND ESTABLISHMENT QUALIFICATIONS.
610	"§ 25-2301. General qualifications for all applicants.
611	"(a)(1) Before issuing, transferring to a new owner, or renewing a license, the Board shall
612	determine that the applicant meets all of the following criteria:
613	"(A) The applicant is at least 21 years of age.
614	"(B) The applicant has not been convicted of an offense that is directly
615	related to the business for which a license is held or sought.
616	"(2) Pursuant to paragraph (a)(1) of this subsection, the Board shall determine
617	whether a conviction of an offense of an applicant or licensee is directly related to the business
618	for which a license is sought or held by considering the totality of the following factors:
619	"(A) Whether the elements of the offense are directly related, by clear and
620	convincing evidence to the specific duties and responsibilities of the business;
621	"(B) Any evidence produced by the applicant or licensee concerning their
622	rehabilitation and fitness, including:
623	"(i) Evidence as to whether the applicant, licensee, registrant,
624	person certified, or person permitted by this act to practice in the District has recidivated;
625	"(ii) Evidence demonstrating compliance with any terms and
626	conditions of probation, supervised release, or parole;
627	"(iii) The length of time that has elapsed since the offense was
628	committed;
629	"(iv) The age at which the offense was committed;
630	"(v) Any circumstances related to the offense, including mitigating
631	circumstances;

632	"(vi) Evidence of work history, particularly any training or work
633	experience related to the occupation; and
634	"(vii) Letters of reference.
635	"(b) A prior conviction for possession of, possession for sale, manufacture,
636	transportation, or cultivation of a controlled substance shall not be the sole ground for denial of a
637	license, provided that, this shall not apply to convictions for hiring, employing, or using a minor
638	in transporting, carrying, selling, giving away, preparing for sale, or peddling, any controlled
639	substance to a minor; or selling, offering to sell, furnishing, offering to furnish, administering, or
640	giving any controlled substance to a minor.
641	"(c) To determine whether an applicant or licensee meets the criteria in this section, the
642	Board may obtain criminal history records of criminal convictions maintained by the Federal
643	Bureau of Investigation and the Metropolitan Police Department. The Board shall:
644	"(1) Inform the applicant that a criminal background check will be conducted;
645	"(2) Obtain written approval from the applicant to conduct a criminal background
646	check;
647	"(3) Coordinate with the Metropolitan Police Department to obtain a set of
648	qualified fingerprints from the applicant; and
649	"(4) Obtain any additional identifying information from the applicant that is
650	required for the Metropolitan Police Department and the Federal Bureau of Investigation to
651	complete a criminal background check.".
652	"25-2302. Restrictions on holding a conflict of interest.

653 "(a) An applicant or licensee shall not hold more than 2 cultivation, manufacturer, or off654 premises retailer's licenses; provided, however, that a licensee may hold 2 off-premises retailer's
655 licenses, 2 cultivation licenses, and 2 manufacturer licenses.

656 "(b) An applicant for a testing facility license shall not hold a direct or indirect interest in
657 a cultivation, manufacturer, microbusiness, or off-premises retailer's license.

658 "(c) A marijuana microbusiness applicant or licensee shall not hold a direct or indirect659 interest in any other license type.

660 "(d) Any licensed facility under this title may be licensed to grow, manufacture, or 661 distribute marijuana under the federal Drug Enforcement Administration Controlled Substances 662 Act registration to supply legitimate researchers in the United States. The ABCA-approved seed 663 to sale tracking system shall be used for these plants, and participation in the federal research 664 program shall be included in the application, annual registration, and license renewal 665 documents.".

666 "§ 25-2303. Ownership by Residents and Local Hire requirements.

667 "(a) Except for those owners of medical marijuana facilities licensed as of the effective 668 date of this Act, an applicant for a cultivation, manufacturer's, microbusiness, or off-premises 669 retailer's license shall have one or more District residents, which individually or collectively, 670 own at least 60% of the licensed establishment. Persons claiming to be District residents shall 671 submit adequate proof of District residency according to standards determined by ABCA and affirm an intent and commitment to maintaining District residency during the period of 672 673 ownership of a licensed facility covered by the requirements of this subsection. Such person or 674 persons designated as District resident owners shall receive a return on investment and shall

675 incur obligations and risks on equal footing with all other owners in proportion to their676 ownership shares.

677 "(b) If the District resident owner(s) who submit proof of residency according to 678 subsection (a) is not a or the majority owner, those who do own such a majority stake, 679 individually or collectively, must affirm on the application, under penalty of perjury, that 680 the 60% owner(s) identified in subsection (a) has and will have all the proportional 681 benefits and obligations accorded to a 60% owner. 682 "(c) Straw ownership for the sake of fulfilling the ownership requirements of this section 683 is banned, both for the District resident(s) and the out of state residents purporting to give the 684 District resident(s) a 60% ownership share in a licensee under this subsection. 685 "(d) Any District resident owner designated as owning at least 60% of the applicant or 686 licensee's business may only satisfy a quarter of its required capital contribution and other indicia 687 and obligations of ownership under this subsection through "sweat equity" — time spent 688 providing services to the company in support of its District licensee pursuant to an agreement 689 describing: 690 "(1) The scope of work that the District resident owner(s) will perform; 691 "(2) The dollar amount that it will be compensated for its services, if any, in 692 addition to the dollar amounts that will be credited to its capital contribution; 693 "(3) The date or time period when the District resident owner(s) will receive 694 compensation and returns on its investment; and 695 "(4) An explanation of when the District resident owner(s) will receive their

696 return or returns as compared to other owners.

697 "(e) Except for those owners of medical marijuana facilities licensed as of the effective 698 date of this Act, a cultivation, manufacturer's, microbusiness or off-premises retailer's licensee 699 shall have at least 60% of its licensed employees submit adequate proof of District residency 700 according to standards determined by ABCA, and that proof shall affirm an intent and severe 701 offenses and encompass occasional or inadvertent failure to comply with basic administrative 702 procedures and protocols or minor changes to plans submitted in licensing documents that do not 703 affect the health, safety, or welfare of the public, nor the integrity of the program established and 704 regulated by this title.

"(f) The Board shall require annual certification of the owners' continued District
residency and upon license renewals may require such proof as it deems necessary of ownership
if such District residency was an element of the initial granting of a license or transfer of a
license, and the Board shall revoke the license of any license holder that no longer maintains the
60% ownership by District residents requirement.

710 "(g) The Board shall require annual certification of compliance with the local hiring 711 requirements. If a licensee covered by local hiring requirements falls below the 60% local hiring 712 requirement and does not submit clear and convincing evidence that it has cured the deficit 713 within 90 days, the Board shall revoke the licensee's license.".

"(h) In addition to any fines imposed for violations or prosecutions, ABCA is authorized
to issue warnings, impose additional conditions on licensees, ban persons who have committed
violations from participating or purchasing cannabis or working in establishments licensed under
this act.

(i) The Board may develop and provide incentives to promote the hiring of District
residents who reside in Disproportionately Impacted Areas as defined in § 25-2101(6).

"(j) Exceptions to local ownership and local hire requirements in subsections (a) and (e)shall apply to license renewals as well as initial licenses.".

722 "§ 25-2304. Qualification of establishments.

"(a) No license shall be issued to an applicant unless he or she provides the Board with a
zoning determination letter, issued by DCRA, stating that the establishment to be licensed is
located within a zone that permits the establishment's operation.

"(b) The applicant shall bear the burden of proving to the satisfaction of the Board that the establishment for which the license is sought is appropriate for the locality, section, or portion of the District where it is to be located; provided, that if proper notice has been given under subchapter II of Chapter 4 of this title, and no objection to the appropriateness of the establishment is filed with the Board, the establishment shall be presumed to be appropriate for the locality, section, or portion of the District where it is located."

"(c) No license shall be issued to an applicant that holds an alcohol license or a license tosell tobacco at the same location unless otherwise authorized by the Board.

"§ 25-2305. Appropriateness standard.

"(a) To qualify for the issuance, renewal of a license, or transfer of a license, an applicant
for a cultivation, manufacturer, microbusiness, or off-premises retailer license shall be required
to satisfy the appropriateness standards set forth in D.C. Official Code § 25-313.

- 738 "(b)(1) The Board shall also consider whether issuance of the license would create or
- contribute to an overconcentration of licensed establishments which is likely to affect adversely
- the locality, section, or portion in which the establishment is located.

741	"(2) The Board may also consider whether there is an under-concentration of
742	licensed establishments in other localities, sections, or portions of the District to ensure a more
743	equitable distribution of establishments.
744	"(c) No marijuana license shall be issued to an outlet, property, establishment or
745	business that sells motor vehicle gasoline or has drive-through sales.".
746	"25-2306. Transfer of licensed establishment to a new owner.
747	"(a) In determining the appropriateness of the transfer of a marijuana establishment to a
748	new owner, the Board shall consider only the applicant's qualifications as set forth in D.C.
749	Official Code § 25-2301, and whether any sale defeats or impairs the social equity thresholds in
750	D.C. Official Code § 25-2106 or the local ownership goals embodied in D.C. Official Code § 25-
751	2303.
752	"(b) Notwithstanding subsection (a), the Board shall deny a transfer of ownership
753	application to a new owner and cancel the marijuana license if the previous applicant
754	either:
755	"(1) Failed to open for business within 180 days of being issued a marijuana
756	license or 365 days for a Social Equity Applicant;
757	"(2) Stopped operating within 90 days of being issued a marijuana license for
758	more than 14 calendar days in the absence of a showing of good cause and approval by ABCA

1147 "(a) Except as permitted by the Board, a microbusiness or off-premises retailer shall not 1148 be authorized to sell any products or services other than cannabis, cannabis products, or cannabis 1149 paraphernalia intended for the storage or use of cannabis or cannabis products. 1150 "(b) It shall be unlawful for microbusinesses or off-premises retailers, or any other 1151 business or person in the District, to offer cannabis or cannabis products via a vending machine. 1152 "(c) Microbusinesses and off-premises retailers shall keep all products secured behind a 1153 counter, locked door, or under glass not accessible to the customer. Customers are not permitted 1154 to help themselves to a product but shall place an order with authorized employees of the 1155 retailer.". 1156 "§ 25-2721. Delivery of cannabis and cannabis products. 1157 "(a) Deliveries shall only be made by the holder of a microbusiness or off-premises 1158 retailer's license that has a delivery endorsement. 1159 "(b) Microbusiness and off-premises retailers shall only be permitted to deliver to a 1160 District residence or at the business location via curbside pickup but shall not be permitted to 1161 deliver to residences located on college campuses and universities. 1162 "(c)(1) The person ordering the delivery shall be at the home or at the business for 1163 curbside pickup at the time of the delivery. 1164 "(2) For purposes of this section, "at the home" includes on the steps of the 1165 residence or in the yard of the residence. 1166 "(d) Prior to transfer of marijuana or marijuana product to the consumer, a microbusiness 1167 or off-premises retailer shall require the person ordering the delivery to sign for the delivery and 1168 shall ensure that the name on the valid identification document matches the name of the 1169 customer who placed the order.

1170 "(e) Marijuana microbusinesses and off-premises retailers offering home delivery or 1171 curbside pickup must state prominently on their website or by telephone that it is illegal under 1172 federal law to receive, possess, or use marijuana in federally-funded public housing under the 1173 Controlled Substances Act, so long as that remains the case.

1174 "(h) Landlords remain free to ban the delivery of combustible marijuana to their tenants 1175 at premises they own, notwithstanding the legality of such delivery.

1176 "(i) If a landlord or property owner posts a sign reasonably designed to be visible from 1177 the front door saying "No combustible marijuana deliveries to this building" any delivery service 1178 must cancel the order for a combustible marijuana product placed by a tenant at the residence.

1179 "(j) Except as may be authorized by the Board in subsection (h), no deliveries shall be 1180 made to licensed businesses, including hotels and restaurants, nor shall deliveries be made to 1181 public parks or in public spaces, and it is an affirmative duty of an off-premises retailer to verify 1182 that the address for delivery is a residential address.

1183 "(h) No deliveries may take place on federally owned land or on the premises of federally 1184 owned buildings.

1185 (i) The Board is authorized to issue regulations regarding verifying the identity and age 1186 of the customer, the status of an address as a residence, and record retention for deliveries. No 1187 sooner than two years after the effective date of this act, the Board may establish a system to 1188 expand permissible delivery locations in the District.".

1189 (j) A new Chapter 28 is added to read as follows:

1190

CHAPTER 28. ENFORCEMENT, INFRACTIONS, AND PENALTIES.

1191 "§ 25-2801. Authority of the Board and ABCA investigators.

1192	"(a) The Board shall have the authority to enforce the provisions of this title with respect
1193	to licensees and with respect to any person not holding a license and selling marijuana and
1194	marijuana products without a license in violation of the provisions of this title.
1195	"(b) ABCA investigators shall issue citations for civil violations of this title that are set
1196	forth in the schedule of penalties established under D.C. Code § 25-2803.
1197	"(c) ABCA investigators may:
1198	"(1) Request and check the identification of a patron inside of or attempting to
1199	enter an establishment with a marijuana license;
1200	"(2) Seize evidence that substantiates a violation under this title, which shall
1201	include the seizing of marijuana or marijuana products believed to have been sold to minors and
1202	fake identification documents used by minors.
1203	"(d) ABCA investigators may seize a marijuana license from an establishment if:
1204	"(1) The marijuana license has been suspended, revoked, or canceled by the
1205	Board;
1206	"(2) The business is no longer in existence; or
1207	"(3) The business has been closed by another District government agency.
1208	"(e) Any show cause enforcement hearings brought by the Board for violations of
1209	this title shall follow the procedures set forth in D.C. Code § 25-447.".
1210	"§ 25-2802. Revocation or suspension of licenses for violations of this title.
1211	"(a) Pursuant to Subchapter II of Chapter 8, the Board may fine, suspend,
1212	summarily suspend or revoke the license of a licensee.
1213	"(b) Pursuant to D.C. Code § 25-827, or if the Chief of Police finds that a licensed
1214	establishment is diverting cannabis product out of state, selling cannabis or cannabis products to

minors, or if the facility is associated with crimes of violence, the Chief of Police may close amarijuana establishment for up to 96 hours.".

1217 "§ 25-2803. Civil penalties.

1218 "(a) In the rules implementing this act, the Board shall include a schedule of civil1219 penalties and fine ranges for violations of this title.

1220 "(b) The schedule shall contain three tiers that shall reflect the severity of the violation1221 for which the penalty is proposed:

1222 "(1) Tier 1 shall apply to violations that may hurt the efficiency and overall
1223 performance of programs for the regulated sale of cannabis, such as failure to comply with basic
1224 administrative procedures and protocols and minor changes to plans that do not affect the health
1225 safety or welfare of the public.

"(2) Tier 2 shall apply to violations that are more severe than Tier 1 but generally do not have an immediate or potential negative impact on the health, safety, and welfare of the public. This tier may include violations of advertising and marketing requirements, violations of packaging and labeling requirements that do not directly impact patient or consumer safety, and minor or clerical errors in the seed-to-sale tracking system.

1231 "(3) Tier 3 shall apply to violations that generally have an immediate or potential
1232 negative impact on the health, safety, and welfare of the public, including selling to minors,
1233 making false statements, or utilizing advertising or marketing materials that target minors.

"(c) The schedule shall contain escalating penalties for repeat violations and a list of
potential mitigating or aggravating factors that may be considered when determining the
imposition of a civil penalty.

1237 "§ 25-2804. Alcohol or tobacco infused marijuana.

1238	"(a) Except in the case of tincture products containing distilled spirits in conformance
1239	with regulations issued by the Tax and Trade Bureau of the United States Department of
1240	Treasury, it shall be unlawful for a person to sell or offer for sale alcohol that has been infused
1241	with marijuana; or marijuana products that have been infused with tobacco products.
1242	"(b) A licensee shall not sell or offer for sale alcohol that has been infused with
1243	marijuana except in the case of tinctures that are infused with distilled spirits in conformance
1244	with regulations issued by the Tax and Trade Bureau; or tobacco products.
1245	"(c) A licensee who violates this section shall be assessed a civil fine in an amount of no
1246	more than \$1,000.".
1247	"§ 25-2805. Tampering with packaging or container.
1248	"(a) A licensee or a licensee's employee shall not knowingly:
1249	"(1) Misrepresent the brand or contents of any marijuana product sold or offered
1250	for sale;
1251	"(2) Tamper with the contents of any marijuana packaging;
1252	"(3) Remove or obliterate any label from marijuana packaging being offered for
1253	sale;
1254	"(4) Deliver or sell the contents of any marijuana packaging that has had its label
1255	removed or obliterated.
1256	"(b) It shall be unlawful for a person to willfully or knowingly alter, forge counterfeit,
1257	endorse, or make use of any false or misleading document reasonably calculated to deceive the
1258	public as being a genuine marijuana license issued by ABCA.".
1259	"§ 25-2806. Vaping devices.

1260 "(a) It shall be unlawful for a person to sell, offer for sale, or give a vaping device to a1261 person who is under 21 years of age.

1262 "(b) A licensee shall not sell, offer for sale, or give a vaping device to a customer who is1263 under 21 years of age.

1264 "(c) A licensee who violates this section shall be assessed a civil fine in an amount of no1265 more than \$1,000.".

1266 "§ 25-2806. Forged licenses.

"(a) It shall be unlawful for a person to willfully or knowingly alter, forge counterfeit,
endorse, or make use of any false or misleading document reasonably calculated to deceive the
public as being a genuine license issued by ABCA.

"(b) It shall be unlawful for a person to willfully or knowingly furnish to a member of
MPD or an ABCA investigator an altered, forged, counterfeited, endorsed or false or misleading
document reasonably calculated to deceive MPD or the ABCA investigator as being a genuine
license issued by ABCA.

"(c) A person convicted of a violation of this section shall be fined no more than
the amount set forth in D.C. Official Code § 22-3571.01, or incarcerated for more than 1
year or both.".

1277 "§25-2807. Other penalties.

"(a) Any person who significantly alters or at all falsifies any reports, documents, or
plans, or misrepresents any information required for licensing or purchasing marijuana under this
title shall be guilty of a misdemeanor and, upon conviction, shall be punished by a fine of not
more than the amount set forth in D.C. Official Code § 22-3571.01, or imprisoned for not more
than one year, or both.

1283 "(b) Any person required to file taxes for sales or transfer of marijuana or marijuana 1284 products under this title who willfully attempts in any manner to evade or defeat a tax, or the 1285 payment there; any person who knowingly diverts marijuana or marijuana products outside of 1286 the regulated system, shall be guilty of a felony and, upon conviction, shall be fined not more 1287 than the amount set forth in D.C. Official Code § 22-3571.01, or imprisoned for not more than 1288 three years, or both. The penalty provided herein shall be in addition to other penalties provided 1289 under District or federal law.

"(c) Violations of this section that are misdemeanors shall be prosecuted on information
filed in the Superior Court of the District of Columbia by the Office of the Attorney General.
Violations of this subsection that are felonies shall be prosecuted by the United States Attorney
for the District of Columbia.

"(d) In addition to any civil penalties or fines imposed, ABCA is authorized to issue
warnings, impose additional conditions on licensees, ban persons who have committed violations
from participating or purchasing cannabis or working in establishments under this act.

"(e) A civil fine may be imposed by ABCA as an alternative sanction for any violation of
this title for which no specific penalty is provided, or any rules or regulations issued under the
authority of this title, under Chapter 18 of Title 2. Adjudication of an infraction that is contested
or appealed under this section shall be heard by OAH pursuant to Chapter 18 of Title 2.".

1301

(j) A new Chapter 29 is added to read as follows:

1302

CHAPTER 29. LIMITATIONS ON CONSUMERS; PUBLIC EDUCATION.

1303 "§ 25-2901. Purchase, possession, use, or consumption by persons under the age of 21;
1304 misrepresentation of age; penalties.

"(a)(1) No person who is under 21 years age shall purchase, attempt to purchase, possess,
use, or consume marijuana or marijuana products in the District, provided that this shall not
apply to minors ages 18 to 20 participating in the District's medical marijuana program.

1308 "(2) Only an authorized parent, legal guardian, or caregiver shall be allowed to
1309 purchase marijuana or marijuana products for minors under the age of 18 who are participating
1310 in the District's medical marijuana program.

"(b) No person shall falsely represent his or her age or possess as proof of age an
identification document which is in any way fraudulent for the purpose of purchasing,
possessing, using, or consuming cannabis in the District.

1314 "(c) No person shall present a fraudulent identification document for the purposes
1315 of entering an establishment possessing an off-premises retailer's license licensed under
1316 chapter 21of this title.

1317 "(d) For the purpose of determining valid representation of age, each person shall be 1318 required to present to the establishment owner or representative at least one form of valid 1319 identification, which shall have been issued by an agency of government (local, state, federal, or 1320 foreign) and shall contain the name, date of birth, signature, and photograph of the individual; 1321 provided, that a military identification card issued by an agency of government (local, state, 1322 federal, or foreign) shall be an acceptable form of valid identification whether or not it contains 1323 the individual's signature.

1324 "(e) Any person guilty of violating this section shall be subject to fines and penalties as1325 follows:

1326 "(1) Upon the first violation, a fine of not more than \$25, or the performance of
1327 10 hours of community service;

1329

"(2) Upon the second violation, a fine of not more than \$50, the performance of 15 hours of community service, or both; and

- 1330 "(3) Upon the third and subsequent violations, a fine of not more than \$100, the1331 performance of 20 hours of community service, or both.
- 1332 "(f) If the individual subject to penalties in subsection (e) is under the age of 18, the
- 1333 Office of Administrative Hearings shall mail a copy of the notice of violation to the parent or
- 1334 guardian of the person to whom the notice of violation is issued at the address provided by the
- 1335 the person at the time the citation is issued pursuant to § 48-1202.
- 1336 "§ 25-2902. Marijuana paraphernalia.

1337 "A person 21 years of age or older shall not be arrested, prosecuted, penalized or

1338 disqualified and shall not be subject to seizure or forfeiture of assets for possessing,

1339 purchasing or otherwise obtaining or manufacturing marijuana accessories or for selling

1340 or otherwise transferring marijuana accessories to a person who is 21 years of age or

1341 older.".

1342 "§ 25-2903. Public education.

1343 "The Board shall develop and implement a public education campaign that includes1344 information on:

"(a) Who is legally authorized to purchase, possess, and use marijuana or marijuana
products pursuant to the Comprehensive Cannabis Legalization and Regulation Act of 2021;

1347 "(b) Sale and dosage limits pursuant to the Comprehensive Cannabis Legalization and1348 Regulation Act of 2021 and applicable regulations;

1349 "(c) Places or locations where the possession and/or use of marijuana or marijuana1350 products are prohibited;

1351 "(d) Methods of marijuana use, including the effects and potentials risks associated with1352 each method;

1353 "(e) The health effects of marijuana use; and

1354 "(f) Responsible use and harm reduction strategies, including safe storage of marijuana

1355 and marijuana products in the home, not operating a motor vehicle while impaired, avoiding the

1356 use of marijuana and marijuana products while pregnant, and not consuming marijuana with

1357 alcohol or other drugs.".

1358 (j) A new Chapter 30 is added to read as follows:

1359 CHAPTER 30. TAXES AND REVENUES.

1360 "§ 25-3001. Imposition and collection of taxes.

1361 "(a)(1) A tax is imposed upon all vendors for the privilege of selling retail marijuana and 1362 marijuana products. The rate of such tax shall be 13% of the gross receipts from sales or charges 1363 for retail marijuana or marijuana products.

1364 "(2) For medical marijuana and medical marijuana products, the rate of such tax1365 shall be 6% of the gross receipts from sales or charges.

1366 "(b) The taxes imposed in subsection (a) shall be collected by the off-premises retailer1367 from the purchaser on all sales of retail marijuana or marijuana products.".

1368 "§ 25-3002. Income taxes and tax exemptions.

1369 "(a) Licensees shall be subject to applicable income taxes pursuant to Chapter 18 of Title

1370 47.

"(b) For License carriers engaged in the commercial cannabis supply chain of cultivation,
manufacturing, and off-premises retail, there shall be allowed as a deduction all the ordinary and
necessary expenses paid or incurred during the taxable year in carrying on any trade or business,

1374 as defined in D.C. Official Code § 47-1803.03(a). Any business expenses allowed under this 1375 paragraph shall be subject to the same limitations as provided for the Internal Revenue Code of 1376 1986; however, a licensed cannabis business shall be allowed, for the purposes of District taxes, 1377 any federal income tax deduction that is disallowed by Internal Revenue Code §280E. This 1378 deduction shall be available for all corporations, including limited liability corporations (LLCs) 1379 and sole proprietors established as corporations. The Office of Tax and Revenue shall accept a 1380 federal pro forma return that includes business expenses and calculate District of Columbia 1381 income tax liability using the pro forma return.

1382 "(c) Deductions prescribed in D.C. Official Code § 47-1803.03(d) shall not be1383 allowed under this Chapter.".

1384 "§ 25-3003. Revenues.

"(a) All funds obtained from initial marijuana licensing and permitting fees shall be
deposited into the Cannabis Equity and Opportunity Fund established in D.C. Official Code §
22-2105.

1388 "(b) All funds obtained from renewal of marijuana licenses and permits, and penalties1389 and fines, shall be deposited into the General Fund of the District of Columbia.

1390 "(c) Except as provided in D.C. Official Code §§ 25-2104 and 25-2108, all funds

1391 obtained from the tax imposed under D.C. Official Code § 25-3001 shall be deposited into the

1392 General Fund of the District of Columbia.".

1393 Sec. 4. The District of Columbia Uniform Controlled Substances Act of 1981, effective

1394 August 5, 1981 (D.C. Law 4-29; D.C. Official Code § 48-901.01 et seq.) is amended as follows:

1408	"(c-1)(1) It is unlawful for any person who is not licensed as a cultivator
1409	under this act or registered as a cultivation center and authorized by regulations promulgated
1410	under the Legalization of Marijuana for Medical Treatment Initiative of 1999, effective July 27,
1411	2010 (D.C. Law 13-315; D.C. Official Code § 7-1671.01 et seq.), to knowingly or intentionally;
1412	"(A) Use butane, hexane, propane, or other explosive gases to extract or
1413	separate resin from marijuana, or Tetrahydrocannabinol from marijuana; or
1414	"(B) Use any other liquid chemical, compressed gas, or commercial
1415	product, other than alcohol or ethanol, that has a flashpoint at or lower than 38 degrees Celsius or
1416	100 degrees Fahrenheit, for the purpose of manufacturing marijuana concentrates.
1417	"(2) Any person who violates this subsection is guilty of a felony and, upon
1418	conviction, may be imprisoned for not more than 3 years, fined not more than the amount set

forth in section 101 of the Criminal Fine Proportionality Amendment Act of 2012, effective June
11, 2013 (D.C. Law 19-317; D.C. Official Code § 22-3571.01), or both.".

1421 Sec. 5. Discrimination prohibited.

1422 "(a) Neither the presence of cannabinoid components or metabolites in a person's bodily 1423 fluids nor possession of cannabis-related paraphernalia, nor conduct related to the use of 1424 cannabis or the participation in cannabis-related activities lawful under this act by a custodial or 1425 non-custodial parent, grandparent, legal guardian, foster parent, or other person charged with the 1426 well-being of a child shall form the sole basis for any action or proceeding by a child welfare 1427 agency or in family or juvenile court, any adverse finding, adverse evidence, or restriction of any 1428 right or privilege in a proceeding related to adoption of a child, acting as a foster parent of a 1429 child, or a person's fitness to adopt a child or act as a foster parent of a child, or serve as the 1430 basis of any adverse finding, adverse evidence or restriction of any right or privilege in a 1431 proceeding related to guardianship, conservatorship, trusteeship, the execution of a will, or the 1432 management of an estate, unless the person's actions in relation to cannabis created an 1433 unreasonable danger to the safety of the minor or otherwise show the person to not be competent 1434 as established by clear and convincing evidence. This section applies only to conduct protected 1435 under this act.

1436 "(b) A person shall not be denied eligibility for public assistance programs based solely1437 on conduct that is permitted under this act unless otherwise required by federal law.

1438 "(c) No landlord may be penalized or denied any benefit under District law for leasing to1439 a person who uses cannabis under this act.

"(d) Nothing in this Act may be construed to require any person or establishment in
lawful possession of property to allow a guest, client, lessee, customer, or visitor to use cannabis
on or in that property.".

1443 Sec. 6. Expungement of marijuana-related arrests and convictions.

"(a)(1) Commencing 180 days after the effective date of this act, the Clerk of the District
of Columbia Superior Court shall conduct a comprehensive review and issue an order expunging
each arrest, prosecution, conviction or adjudication of juvenile delinquency for a violation of the
District of Columbia Uniform Controlled Substances Act of 1981, effective August 5, 1981
(D.C. Law 4-29; D.C. Official Code § 48-901.02 *et seq.*) relating to marijuana or marijuana

1449 paraphernalia except as provided in subsection (c).

(2) The order shall direct the prosecutor, any law enforcement agency, and any
pretrial, corrections, or community supervision agency to expunge any affected arrests,
prosecutions, or convictions.

1453 "(b) At any point after the effective date of this Act, any individual with a prior arrest, 1454 prosecution, conviction or adjudication of juvenile delinquency relating to marijuana or 1455 marijuana paraphernalia under the District of Columbia Uniform Controlled Substances Act of 1456 1981, effective August 5, 1981 (D.C. Law 4-29; D.C. Official Code § 48-901.02 et seq.), who is 1457 not under a criminal justice sentence, may file a motion for expungement, except for offenses in 1458 subsection (c). If the expungement of such an arrest, prosecution, conviction, or adjudication of 1459 juvenile delinquency is required pursuant to this Act, the court shall issue an order to expunge the arrest, prosecution, conviction, or adjudication and any associated arrests. If the individual is 1460 1461 indigent, counsel shall be appointed to represent the individual in any proceedings under this 1462 subsection.

1463	"(c) Subsections (a) and (b) shall not apply to cases that involving the distribution or sale
1464	of marijuana to minors, except if the arrest or charge was dismissed with prejudice.".
1465	Sec. 7. Modification of sentences for marijuana-related convictions.
1466	"(a)(1) A defendant serving a sentence for a conviction, whether by trial or by open or
1467	negotiated plea, of the District of Columbia Uniform Controlled Substances Act of 1981,
1468	effective August 5, 1981 (D.C. Law 4-29; D.C. Official Code § 48-901.02 et seq.) relating to
1469	marijuana or marijuana paraphernalia may file an application to vacate, set aside, or correct the
1470	sentence.
1471	"(2) The defendant shall be present at any hearing conducted under this section
1472	unless the defendant waives the right to be present. Any proceeding under this section may occur
1473	by video teleconferencing, and the requirement of a defendant's presence is satisfied by
1474	participation in the video teleconference.
1475	"(3) The court shall issue an opinion in writing stating the reasons for granting or
1476	denying an application under this section, but the court may proceed to sentencing immediately
1477	after granting an application.
1478	"(b) In determining whether to vacate, set aside, or correct a sentence pursuant to
1479	subsection (a) of this section, the court may consider:
1480	"(1) The defendant's criminal conviction history, including the types of crimes
1481	committed, the length of prison commitments, and the remoteness of crimes;
1482	"(2) The defendant's disciplinary record and record of rehabilitation while
1483	incarcerated; and
1484	"(3) Any other evidence the court, within its discretion, determines to be relevant.

1485 "(c) Any defendant whose sentence is reduced under this section shall be resentenced
1486 pursuant to D.C. Official Code § 24-403, § 24-403.01, or § 24-903, as applicable.

1487 "(d) This section shall not apply to convictions involving the distribution or sale of1488 marijuana to minors.".

1489 Sec. 8. Employment and legal cannabis use.

1490 "(a) Except as otherwise provided by law and subsections (b), (c), and (d) of this section, 1491 it shall be unlawful for an employer to refuse to hire or to discharge any individual, or otherwise 1492 disadvantage any individual, with respect to compensation, terms, conditions, or privileges of 1493 employment because he or she lawfully consumes cannabis or cannabis products off the 1494 premises of the employer during nonworking and non-call hours. For purposes of this section, an 1495 employee is deemed on-call when the employee is scheduled with at least 24 hours' notice by his 1496 or her employer to be on standby or otherwise responsible for performing tasks related to his or 1497 her employment either at the employer's premises or other previously designated location by his 1498 or her employer or supervisor to perform a work-related task.

1499 "(b) Nothing in subsection (a) shall:

1500 "(1) Prohibit an employer from adopting reasonable zero tolerance or drug-free
1501 workplace policies, or employment policies concerning drug testing, smoking, consumption,
1502 storage, or use of cannabis in the workplace or while on-call provided that the policy is applied
1503 in a nondiscriminatory manner;

1504 "(2) Require an employer to permit an employee to be under the influence of or
1505 use cannabis in the employer's workplace o while performing the employee's job duties or while
1506 on call; or

1507 "(3) Limit or prevent an employer from disciplining an employee or terminating
1508 the employment of an employee for violating an employer's employment policies or workplace
1509 drug policy.

If an employer elects to discipline an employee on the basis that the 1519 employee is under the influence or impaired by cannabis, the employer must afford the employee 1520 a reasonable opportunity to contest the basis of the determination.

1521 "(d) Nothing in this section shall be construed to create or imply a cause of action for any1522 person against an employer for:

1523 "(1) Actions, including subjecting an employee or applicant to reasonable drug 1524 and alcohol testing under the employer's workplace drug policy, including an employee's refusal 1525 to be tested or to cooperate in testing procedures or disciplining or termination of employment, 1526 based on the employer's good faith belief that an employee used or possessed cannabis in the 1527 employer's workplace or while performing the employee's job duties or while on call in violation 1528 of the employer's employment policies;

1529 "(2) Actions, including discipline or termination of employment, based on the 1530 employer's good faith belief that an employee was impaired as a result of the use of cannabis, or 1531 under the influence of cannabis, while at the employer's workplace or while performing the 1532 employee's job duties or while on call in violation of the employer's workplace drug policy; or

1533 "(3) Injury, loss, or liability to a third party if the employer neither knew nor had1534 reason to know that the employee was impaired.

"(e) Nothing in this section shall be construed to interfere with any federal restrictions on
employment or impact an employer's ability to comply with federal law or cause it to lose
federal contract or funding.".
