10 11 12 13	To revise the method for school budgeting for the District of Columbia Public Schools by budgeting the local schools first based on each school's previous year's budget, with the remainder to be allocated between central administration and system-wide school support.
14	BE IT ENACTED BY THE COUNCIL OF THE DISTRICT OF COLUMBIA, That this
15	act may be cited as the "Schools First in Budgeting Amendment Act of 2022".
16	TITLE I. DCPS BUDGET
17	Sec. 101. This title may be cited as the "Schools First in Budgeting Amendment Act of
18	2022".
19	Sec. 102. Definitions.
20	For the purposes of this title, the term:
21	(1) "Central Administration" means the programs, services, and employees that
22	support the functions necessary for the governance of the DCPS school district as a whole,
23	including general oversight and management of support services, such as procurement, human
24	resources, and financial administration, whose costs are not attributable to School Support,
25	School-Wide, or Local Schools.
26	(2) "DCPS" means the District of Columbia Public Schools system.

27	(3) "Local Schools" means the individual schools comprising the DCPS system
28	and whose programs, services, and employees are paid with funds under the control and direction
29	of the individual school principals.
30	(4) "Projected enrollment" is the number of students projected to be enrolled at a
31	specific DCPS school at the time the Mayor's budget is proposed to the Council.
32	(5) "School Support" means the programs, services, and employees that provide
33	system-wide support to DCPS schools, such as curriculum development, instructional
34	superintendents, teacher evaluations, and professional development, whose costs are not
35	attributable to Central Administration, School-Wide, or Local Schools.
36	(6) "School-Wide" means the programs, services, and employees that directly
37	support schools and are budgeted centrally but provided directly to individual schools, such as
38	food service, security, fixed costs, speech therapists, itinerant ELL services, and substitute
39	teachers, whose costs are not attributable to Central Administration, School Support, or Local
40	Schools.
41	(7) "Uniform Per Student Funding Formula" means the formula for funding
42	DCPS and the District's public charter schools established pursuant to the Uniform Per Student
43	Funding Formula for Public Schools and Public Charter Schools Act of 1998, effective March
44	26, 1999 (D.C. Law 12-207; D.C. Official Code § 38-2901, et seq.).
45	Sec. 103. DCPS's annual budget.
46	(a) The annual operating budget for DCPS shall be allocated among 4 departments:

47	(1) Central Administration;
48	(2) Local Schools;
49	(3) School Support; and
50	(4) School-Wide.
51	(b) The Chancellor of DCPS ("Chancellor") shall prepare and execute a performance-
52	based budget on an annual basis. The budget prepared by the Chancellor shall have its operations
53	organized by major programs, which in turn will be composed of activities and services. The
54	budget submitted by the Chancellor shall allocate all monies by revenue source for programs,
55	activity, and service levels, and by revenue source for comptroller source group by program and
56	activity. The DCPS submission shall include the number of full-time equivalents with job titles
57	by program and revenue source.
58	(c) The DCPS annual budget submission shall also include a delineation of:
59	(1) All funds budgeted for each school, including a summary statement or table of
60	the local-funds budget for each school, by revenue source for activities and service levels, and by
61	revenue source for comptroller source group by activities and service levels;
62	(2) The programs and services, along with a narrative description of each program
63	and service;
64	(3) All funds not allocated directly to a school or to Central Administration, by
65	revenue source for activities and service levels, and by revenue source for comptroller source
66	group by activities and service levels, including a presentation of:

67	(A) Any funds that will support costs associated with programs and
68	services provided at the school level or directly to students; and
69	(B) Any funding associated with at-risk students and with the at-risk high
70	school over-age supplement that has been retained by the Chancellor;
71	(4) The methodology used to determine each school's local funding;
72	(5) For each school's individual budget, a separate budget line item for funding
73	allocated to the following, as coded in the District's current official financial system of record:
74	(A) At-risk students;
75	(B) The at-risk high school over-age supplement;
76	(C) Elementary ELL; and
77	(D) Secondary ELL; and
78	(6) For each school, a matrix depicting the projected enrollment for the categories
79	listed in subparagraph (A) of this paragraph delineated by the categories listed in subparagraph
80	(B) of this paragraph.
81	(A) Total projected enrollment for:
82	(i) Each grade level the school serves;
83	(ii) Students in an alternative program;
84	(iii) Students receiving special education services; and
85	(iv) Students in an adult education program.
86	(B) Projected number of students who qualify as:

87	(i) General education (receiving no special education services);
88	(ii) Level 1: Special Education;
89	(iii) Level 2: Special Education;
90	(iv) Level 3: Special Education;
91	(v) Level 4: Special Education;
92	(vi) Special Education Level 1 Extended School year ("ESY");
93	(vii) Special Education Level 2 ESY;
94	(viii) Special Education Level 3 ESY;
95	(ix) Special Education Level 4 ESY;
96	(x) Limited English Proficient/Non-English Proficient;
97	(xi) At-risk;
98	(xii) At-risk high school over-age supplement.
99	(d) Annually, no later than 42 calendar days before the Mayor's submission of the
100	District's budget and financial plan to the Council and in accordance with section 104(d), the
101	Chancellor shall make available on DCPS's website a detailed estimate of the amount of money
102	required to operate DCPS for the ensuing year, including the Schools First budget for each
103	school.
104	(e) The Mayor's annual submission of the District's budget and financial plan to the
105	Council shall include as an attachment an accurate and verifiable report on the positions and
106	employees of DCPS to include:

107	(1) A compilation of DCPS Schedule A positions for the ensuing fiscal year on a
108	full-time equivalent basis, including a compilation of all positions by organization Level 4, job
109	title, pay plan and grade, program and activity, revenue fund, and annual salary; and
110	(2) A compilation of all DCPS employees as of the preceding March 1, on a full-
111	time equivalent basis, including a compilation of all positions by organization Level 4, job title,
112	pay plan, grade, and step, program and activity, revenue fund, and annual salary.
113	(f) No later than October 30 of each year, the Mayor shall submit to the Council a revised
114	appropriated funds operating budget for DCPS for the fiscal year beginning on the preceding
115	October 1 (i.e., the current fiscal year) that sets forth the total amount of the approved
116	appropriation and that realigns budgeted data with anticipated actual expenditures with the
117	specification set forth in of subsections (a), (b), and (c) of this section.
118	(g) Beginning in fiscal year 2011, the Mayor shall submit to the Council quarterly
119	financial reports for DCPS setting forth by organization Level 4 approved budget, revised
120	budget, actual expenditures and funds obligated to date, and projected expenditures for the full
121	fiscal year.
122	(h) By March 31, 2024, and annually thereafter, the Mayor shall transmit a report of the
123	previous school year's actual expenditures, for each school, to the Office of the State
124	Superintendent of Education. The report shall conform to the common financial reporting
125	standards established by the Department of Education pursuant to section 202(b)(10) of the

126	Department of Education Establishment Act of 2007, effective June 12, 2007 (D.C. Law 17-9;
127	D.C. Official Code § 38-191(b)(10)).
128	(i) For the purposes of this section:
129	(1) The following terms shall have the same meaning as provided in section 102
130	of the Uniform Per Student Funding Formula for Public Schools and Public Charter Schools Act
131	of 1998, effective March 26, 1999 (D.C. Law 12-207; D.C. Official Code § 38-2901):
132	(A) "Adult education";
133	(B) "Alternative program";
134	(C) "At-risk";
135	(D) "At-risk high school over-age supplement";
136	(E) "Elementary ELL";
137	(F) "Limited English Proficient/Non-English Proficient"; and
138	(G) "Secondary ELL".
139	(2) The following terms shall have the same meaning as provided in section 106
140	of the Uniform Per Student Funding Formula for Public Schools and Public Charter Schools Act
141	of 1998, effective March 26, 1999 (D.C. Law 12-207; D.C. Official Code § 38-2901):
142	(A) "At-risk high school over-age supplement";
143	(B) "Level 1: Special Education";
144	(C) "Level 2: Special Education";
145	(D) "Level 3: Special Education";

146	(E) "Level 4: Special Education";
147	(F) "Limited English Proficient/Non-English Proficient";
148	(G) "Special Education Level 1 Extended School year ("ESY")";
149	(H) "Special Education Level 2 ESY";
150	(I) "Special Education Level 3 ESY"; and
151	(J) "Special Education Level 4 ESY".
152	Sec. 104. Schools First budgets.
153	(a) In formulating the annual DCPS operating budget for submission to the Council, the
154	annual budget for each DCPS school for the next fiscal year ("Schools First budget") shall be
155	determined according to the following sequence:
156	(1) Begin with the total amount of funds under the control and direction of the
157	school's principal for the current school year (obligated and unobligated) as of January 1 of the
158	current fiscal year, excluding:
159	(A) Privately raised funds;
160	(B) Pandemic Supplement Funds as authorized by section 106b of the
161	Uniform Per Student Funding Formula for Public Schools and Public Charter Schools Act of
162	1998, effective September 21, 2022 (D.C. Law 24-167; D.C. Official Code § 38-2905.02);
163	(C) Federal Elementary and Secondary School Emergency Relief funds:

164	(D) Federal Investment in Schools funds as authorized by section 1003 of
165	the Elementary and Secondary Education Act of 1965, approved January 8, 2002 (115 Stat. 1442;
166	20 U.S.C. § 6303)); and
167	(E) District at-risk concentration supplement funds authorized by section
168	106a(c-2) of the Uniform Per Student Funding Formula for Public Schools and Public Charter
169	Schools and Tax Conformity Clarification Amendment Act of 1998, effective September 21,
170	2022 (D.C. Law 24-167; D.C. Official Code § 38-2905.01(c-2)).
171	(2) Increase the amount in paragraph (1) of this subsection by the percentage that
172	is the higher of:
173	(A) The projected increase for the forthcoming year in the foundation level
174	of the Uniform Per Student Funding Formula ("UPSFF"); or
175	(B) The collectively bargained salary increase, for the forthcoming year,
176	for members of the teachers' union.
177	(3) Increase the amount derived pursuant to paragraph (2) of this subsection to
178	fully fund an increase in the number of general education personnel at the school by the greater
179	of the amount agreed to by the Chancellor or the amount necessary to fully fund an increase in
180	the number of personnel required by the school's projected or actual enrollment increases (in one
181	year, or over time), when such enrollment increases require one or more additional instructional
182	or school-based support personnel (require such as per the collective bargaining agreement with
183	the teachers' labor union).

184	(4) Increase the amount derived pursuant to paragraph (3) of this subsection to
185	reflect fully the increase of special education or English learner ("ELL") personnel so that the
186	levels of such staff align with required service levels for students.
187	(5) Increase the amount derived pursuant to paragraph (4) of this subsection to
188	fund fully any additional costs the school may be required to carry, such as the transfer of
189	services to Local Schools that were previously attributed to School Support, School-Wide, or
190	Central Administration.
191	(6) The amount derived pursuant to paragraph (5) of this subsection may be
192	decreased, incrementally, if the school's projected enrollment for the next school year is
193	projected to decline; provided, that:
194	(A) The decrease shall be made only on a full-time equivalent employee
195	basis (using average salary);
196	(B) The decrease shall not be made unless the enrollment decline is great
197	enough on the grade or subject level to eliminate a classroom or warrant elimination of
198	instructional or school-based support personnel; and
199	(C) After the decrease, the school will still comply with the class size
200	maximums set forth in the operative collective bargaining agreement with the teachers' labor
201	union.
202	(7) The amount derived pursuant to paragraph (6) of this subsection may be
203	decreased, incrementally, to reflect a reduced need for special education or ELL personnel;

provided, that the funding for such faculty shall align fully with the required service levels for students.

- (8) As applicable, increase the amount derived pursuant to paragraph (7) of this section by the amount to be allocated to the school through the at-risk concentration supplement provided pursuant to section 106a(c-2) of the Uniform Per Student Funding Formula for Public Schools and Public Charter Schools Act of 1998, effective September 21, 2022 (D.C. Law 24-167; D.C. Official Code § 38-2905.01(c-2)).
- (9) After completing the calculations set forth in paragraphs (1) through (8) of this subsection, a school's annual budget may be increased by an amount, if any, agreed to by the Chancellor.
- (b) Nothing in subsection (a) of this section shall be construed to preclude a school principal from requesting additional funding, nor preclude the Chancellor from granting additional funding for reasons not enumerated in subsection (a) of this section.
- (c) For the purposes of deriving the Schools First budget described in subsection (a) of this section, personal services shall be funded based on the system-wide average salary for each personnel position, as determined by the District's Chief Financial Officer or in accordance with the collective bargaining agreement with the teachers' labor union. Any difference between the cost of a position's average salary and an employee's actual salary shall be charged or credited out of funds allocated to School-Wide.

(d)(1) The Schools First budget and the amounts derived from each of the calculations
required pursuant to each paragraph of subsection (a) of this section shall be public record. The
Chancellor shall publish the calculations and the Schools First budget for each DCPS school on
the DCPS website no later than 42 calendar days before the date the Mayor is required to submit
to the Council the District's proposed annual budget and financial plan for the next fiscal year.
The Chief Financial Officer shall include the Schools First budget for each DCPS school in the
budget books transmitted with the Mayor's proposed budget and financial plan.
(2) Any depiction of a school budget created or calculated by methods other than
those described in subsection (a) of this section, such as one that might attribute funds from
School Support or School-Wide to an individual school, shall not contain the words "Schools
First" in the title.

250	Sec. 302. Effective date.
251	This act shall take effect following approval by the Mayor (or in the event of veto by the
252	Mayor, action by the Council to override the veto), and shall remain in effect for no longer than
253	90 days, as provided for emergency acts of the Council of the District of Columbia in section
254	412(a) of the District of Columbia Home Rule Act, approved December 24, 1973 (87 Stat. 788;
255	D.C. Official Code § 1-204.12(a)).
