14	BE IT ENACTED BY THE COUNCIL OF THE DISTRICT OF COLUMBIA, That this
15	act may be cited as the "Targeted Historic Preservation Assistance Temporary Amendment Act
16	of 2023".
17	Sec. 2. Section 11b of the Historic Landmark and Historic District Protection Act of
18	1978, effective March 2, 2007 (D.C. Law 16-189; D.C. Official Code § 6-1110.02), is amended
19	by adding a new subsection (g-1) to read as follows:
20	"(g-1)(1) A grant may be made to a qualified taxpayer under subsection (e)(1) of this
21	section who owns a unit in a multifamily common interest community, as defined in section
22	2232(3) of the Common Interest Community Repairs Amendment Act of 2018, effective October
23	30, 2018 (D.C. Law 22-168, D.C. Official Code § 42-2071(3)) ("Common Interest Community
24	Repairs Amendment Act"), located in Square 2594, for the cost of rehabilitation by the common
25	interest community attributable to the taxpayer.

26	"(2) The Mayor shall ensure that all funds granted to a taxpayer who owns a unit
27	in a common interest community are used to pay for the approved rehabilitation work.
28	"(3) If the grant is to be used for the cost of rehabilitation to common elements, as
29	defined in section 2232(2) of the Common Interest Community Repairs Amendment Act, the
30	preservation covenant required under subsection (i) of this section must be entered into by the
31	unit owners' association or, if applicable, the master association.".

33	This act shall apply as of August 5, 2021.

39	(a) This act shall take effect following approval by the Mayor (or in the event of veto by
40	the Mayor, action by the Council to override the veto), a 60-day period of congressional review
41	as provided in section 602(c)(2) of the District of Columbia Home Rule Act, approved December
42	24, 1973 (87 Stat. 813; D.C. Official Code § 1-206.02(c)(2)), and publication in the District of
43	Columbia Register.
44	(b) This act shall expire after 225 days of its having taken effect.
