48	increase is lower than the rent increase in the original notice.".
49	"(2) Any payment of rent in excess of the legal allowable rent charged that was

50	made in accordance with notices of rent increases issued prior to the effective date of this act shall
51	be repaid to the payer within 30 days after overpayment or by August 1, 2023, whichever is later.
52	"(j) Notwithstanding subsection (h)(2) of this section, the total amount of adjustments from
53	May 1, 2023, to April 30, 2025, shall not exceed the legal rent charged on April 30, 2023, for the
54	unit plus:
55	"(1) 8%, if the unit is occupied by an elderly tenant or tenant with a disability, or if
56	the unit is leased or co-leased by a home and community-based services waiver provider; or
57	"(2) 12%, if the unit is occupied by any other tenant.".

60	"(a-1) Notwithstanding section 208(h) or subsection (a) of this section, an adjustment that
61	takes effect from July 1, 2023, to April 30, 2025, in the amount of rent charged while a unit is
62	occupied by an elderly tenant or tenant with a disability, without regard to income, shall not exceed
63	the rent charged for the unit, plus the least of:
64	"(1) The adjustment of general applicability;
65	"(2) The most recent annual cost-of-living adjustment of benefits for social security
66	recipients established pursuant to section 415(i) of the Social Security Act approved August 28,
67	1950 (64 Stat. 506; 42 U.S.C. § 415(i)); or
68	"(3) 4% of the rent charged.".

76	Sec. 5. Effective date.
77	(a) This act shall take effect following approval by the Mayor (or in the event of veto by the
78	Mayor, action by the Council to override the veto), a 30-day period of congressional review as
79	provided in section 602(c)(1) of the District of Columbia Home Rule Act, approved December 24,
80	1973 (87 Stat. 813; D.C. Official Code § 1-206.02(c)(1)), and publication in the District of
81	Columbia Register.
82	(b) This act shall expire after 225 days of its having effect.
