1 2 3 4 5 A CEREMONIAL RESOLUTION 6 7 IN THE COUNCIL OF THE DISTRICT OF COLUMBIA 8 9 10 To recognize the International Day to End Violence Against Sex Workers, and to declare Tuesday 11 December 17, 2019, as "International Day to End Violence Against Sex Workers" in the 12 District of Columbia. 13 14 WHEREAS, sex workers, or people who offer sexual services in exchange for something of value, are disproportionately targeted for violence around the globe and in the District of 15 16 Columbia; 17 WHEREAS, criminalization of sex work and the accompanying stigma lead to sex 18 19 workers being viewed as less worthy of having their human rights respected and protected, as exemplified by the comments of Gary Ridgeway, the Green River Killer, after admitting to the 20 21 murders of over 70 women in Washington State, "I picked prostitutes because I thought I could 22 kill as many of them as I wanted without getting caught"; 23 WHEREAS, sex workers organized the first International Day to End Violence Against 24 Sex Workers on the date of Ridgeway's conviction, to draw attention to the impunity with which people commit violence against sex workers, and the obstacles sex workers face when attempting 25 26 to report violence; 27 WHEREAS, studies in the U.S. have revealed that as many as 80% of street-based sex 28 workers have faced violence in the course of their work: 29 WHEREAS, research in the District of Columbia has found that more than half of sex workers who reached out to police for help received negative reactions, and one in ten had been 30

subject to physical or sexual violence at the hands of law enforcement;

32 33 34	WHEREAS, this violence disproportionately affects people involved in commercial sex who are marginalized in other ways, such as women, people of color, transgender individuals, migrants, and young people;
35	WHEREAS, two women were murdered this year in an area where commercial sex
36	occurs and there are surely countless other acts of violence against sex workers in D.C. this year
37	which have not been reported;
38	WHEREAS, the District of Columbia strives to be a city that is welcoming and safe for
39	all residents and visitors, and ending violence in our communities is a high priority;
40	WHEREAS, the International Day to End Violence Against Sex Workers is
41	commemorated on December 17 around the world; and
42	WHEREAS, in the District of Columbia, a memorial event has been planned by
43	community members and organizations to recognize International Day to End Violence Against
44	Sex Workers.
45	RESOLVED, BY THE COUNCIL OF THE DISTRICT OF COLUMBIA, that this
46	resolution may be cited as the "International Day to End Violence Against Sex Workers
47	Recognition Resolution of 2019".
48	Sec. 2. The Council of the District of Columbia recognizes the human rights of sex workers,
49	including their right to be free from violence, and declares Tuesday, December 17, 2019 as
50	"International Day to End Violence Against Sex Workers" in the District of Columbia.
51	Sec. 3. This resolution shall take effect immediately upon the first date of publication in
52	the District of Columbia Register.
