

A CEREMONIAL RESOLUTION

IN THE COUNCIL OF THE DISTRICT OF COLUMBIA

To recognize and honor Calvin Smith for his commitment to public health causes in Ward 8 and the District of Columbia and his leadership as Chair of the Ward 8 Health Council.

WHEREAS, on Calvin Smith is a native Washingtonian;

WHEREAS, Calvin Smith earned a Bachelor of Arts degree in Economics from Howard University and a Certificate of Public Administration from George Washington University;

WHEREAS, his extensive experience includes serving as Director of Human Services, Planning & Public Safety for Metropolitan Washington Council of Governments (COG) and Regional Vice President for Lockheed Martin, Information Management Solutions;

WHEREAS, Calvin Smith currently serves as Director of Government and Community Relations for BridgePoint Healthcare and Chair of the Ward 8 Health Council;

49 numerous Board of Directors for nonprofits and other advocacy organizations;

51 resolution may be cited as the “Calvin Smith Recognition Ceremonial Resolution of 2021.”
