Biographical Sketch For Sandra C. "Sandy" Allen

Sandra C. "Sandy" Allen is the former Ward Eight Representative to the Council of the District of Columbia. She was elected to her first term on November 6, 1996, and re-elected to a second term November 8, 2000. She was the Chairperson of the Committee on Human Services. Additionally, she served on 3 other Committees: Consumer and Regulatory Affairs, Public Works & the Environment, and Public Service.

Prior to being elected to the Council of the District of Columbia, Sandy spent 17 years of her professional career in the District of Columbia Government. During that time period, 12 of those years were served as an Advisory Neighborhood Commissioner in Ward Eight, where she continually kept her hand on the pulse of the people.

- "Interim Disability Assistance Amendment Act of 2000" Provides temporary assistance to adults with disabilities while awaiting approval for permanent financial assistance.
- "Retail Service Station Amendment Act of 2000" Placed a moratorium on the conversion of full service stations to retail service stations for a period of three years.
- "Nurse's Rehabilitation Program Act of 2000" Institutes the treatment and rehabilitation program for impaired nurses who are unable to perform his or her professional responsibilities due to drug or alcohol dependency or mental illness.
- "Child and Family Services Agency Establishment Amendment Act of 2000" Creates a new cabinet level agency dedicated to the well being of families and children in Washington, DC.

Year 2001

- "Medicaid Provider Fraud Prevention Amendment Act of 2001" Mandates that all Medicaid fraud statutes in the District of Columbia be enforced by the Office of the Inspector General as well as the Office of the Corporation Council.
- "Department of Mental Health Establishment Amendment Act of 2001" Creates a new cabinet level agency that provides additional financial assistance and more attention to the problems facing the mental health community.
- "Public Disclosure of Findings and Information in Cases of Child Fatality or Near Fatality Amendment Act of 2001" Grants the District of Columbia the authority to release findings and information regarding a child fatality or near fatality; unless such disclosure endangers the life or physical well being of the child.

Year 2002

- "Misdemeanor Jury Trial Act of 2002" Requires that trials be determined by a jury where the cumulative maximum penalty is more than 180 days or \$1,000 fine.
- "Health-Care Facility Unlicensed Personnel Criminal Background Check Amendment Act of 2002"
 Requires that background checks be made no earlier than 30 days prior to an offer of employment and limits the period in which criminal conviction can bar a person from employment for 5 years.
- "Free Clinic Assistance Program Extension Amendment Act of 2002" Extends the life of the free clinic assistance program for three years in the District of Columbia.
- "Improved Child Abuse Investigations Amendment Act of 2002" Broadens and clarifies the definition of child abuse and neglect through requiring disciplinary teams to investigate incidents of child abuse and neglect in the District of Columbia.
- "Health Care and Community Residence Facility, Hospice and Home Care Licensure Penalties Amendment Act of 2002" Increases the penalty for violating this law to a misdemeanor offense and a fine not to exceed \$25,000.
- "Mental Health Civil Commitment Act of 2002" Changes the manner in which persons with mental illness are treated by providing outpatient treatment and expanding the treatment options for persons with mental illness in the District of Columbia.
- "Surname Choice Amendment Act of 2002" Gives a parent at the birth of a child, the rite to give that child the surname of the mother, the father or both.
