RESOLVED, BY THE COUNCIL OF THE DISTRICT OF COLUMBIA, that this resolution may be cited as the "Commission on Asian and Pacific Islander Community Development Meina Banh Confirmation Resolution of 2016".

Sec. 2. The Council of the District of Columbia confirms the appointment of:

CONSUMER FINANCIAL PROTECTION BUREAU (CFPB), Policy and Innovation Advisor, Office of Financial Education (OFE)

Ms. Banh also served as Legislative Assistant to Congressman Mike Honda and was core staff member to the Congressional Asian Pacific American Caucus (CAPAC). In addition, she has worked with local AAPI

organizations including National Coalition for Asian Pacific American Community Development (National CAPACD) and the Pacific Asian Consortium for Employment.
