Ms. Heather Powers is an Adult and Child Therapist, LICSW, at the Wendt Center.

Ms. Powers began her work in the field of community service in 1995 when she began working at the Battered Women's Program in Baton Rouge, Louisiana, as a child advocate in their emergency shelter. She came to Washington, D.C. and started working as a counselor with at risk youth at Sasha Bruce Youthwork, counseling 18-21 year olds in transitional housing; many of whom experienced abusive relationships. During her seven year tenure at Sasha Bruce, Ms. Powers also worked as a case manager with families moving from homelessness into permanent housing. In

2004 she began working at Women Empowered Against Violence (WEAVE) providing therapy to domestic violence survivors. She continues her work with domestic violence survivors, where she provides therapeutic crisis intervention and ongoing therapy, as survivors of trauma move on their journey from striving to thriving.

Ms. Powers obtained her Bachelor's Degree from Louisiana State University and her Master's from the University of Chicago.
