Gregory Jackson, Jr. is an experienced community organizer, skilled at engaging diverse communities. Mr. Jackson currently serves as the National Field Director and States Manager at For Our Future, an organization that works to empower, organize, and mobilize voters on local issues in five states across the U.S.

In 2011, Mr. Jackson was officially named North Carolina's Field Director for President Barack Obama's re-election efforts, leading a team of over 400 staff members. He also worked as the Deputy Director of Volunteer Operations for the Presidential Inauguration Committee and oversaw a successful

operation to recruit, train, and deploy over 14,000 volunteers to support the execution of the 57th Presidential Inaugural Events. In 2013, Mr. Jackson became the Southern Regional Director at Organizing for Action and led their initial organizing efforts advocating for measures to prevent gun violence. After personally surviving a life-threatening incident of gun violence, Gregory transitioned to working for the Democratic Congressional Campaign Committee (DCCC), and in 2014 became the National Field Director at the DCCC.

In 2015, Mr. Jackson joined the Bowser Administration as Director of Community Relations and Services. In this capacity, Gregory built out an office that engaged residents and effectively addressed constituent concerns. His office executed major projects, such as building out a revolutionary response initiative called the Community Stabilization Protocol that provides wrap-around services to communities traumatized by violence.

A Ward 8 Resident, Mr. Jackson received his Bachelor of Science in Political Science from the University of Virginia.
