
Enclosed for consideration and approval by the Council of the District of Columbia is proposed emergency legislation entitled "Proposed Multiyear Contract No. DCAM-16-NC-0105C Aggregate Award Group 3 Approval Emergency Act of 2016" and "Proposed Multiyear Contract No. DCAM-16-NC-0105C Aggregate Award Group 3 Approval Emergency Declaration Resolution of 2016". Also enclosed are background materials required for Council review of the multiyear Agreement for Trash Collection Services, Contract No. DCAM-16-NC-0105C ("the Contract") with F & L Construction, Inc. ("the Contractor").

Under the Contract, the Contractor would provide trash collection services to District Government locations listed in Aggregate Award Group 3 (i.e., front-end service, Wards 1-8). The proposed Contract contemplates a 2 year base period of performance, at a price not to exceed One Million Four Hundred Twenty-Four Thousand Six Hundred Ninety-Six dollars (\$1,424,696.00). The proposed Contract also provides three (3) one (1) year extension options.

Council approval of the proposed multiyear Contract is required pursuant to section 451(c)(3) of the District of Columbia Home Rule Act. In addition to the Contract, attached are: (i) a contract summary; (ii) a fiscal certification; (iii) a legal certification; and (iv) Clean Hands certification for F&L.

A PROPOSED RESOLUTION

To declare the existence of an emergency with respect to the need to approve multiyear Contract No. DCAM-16-NC-0105C with F & L Construction, Inc. to provide trash collection services to various District locations in Aggregate Award Group 3.

BE IT RESOLVED, BY THE COUNCIL OF THE DISTRICT OF COLUMBIA,

That this resolution may be cited as the "Proposed Multiyear Contract No. DCAM-16-NC-0105C Aggregate Award Group 3 Approval Emergency Declaration Resolution of 2016".

Sec. 2.(a) There exists an immediate need to approve Contract No. DCAM-16-NC-0105C between the District and F&L Construction, Inc. to provide trash removal services at various District of Columbia facilities in Aggregate Award Group 3.

(b) Approval of Contract No. DCAM-16-NC-0105C is necessary for the District to enter into a long-term agreement with F&L Construction, Inc. to provide trash removal services at District of Columbia facilities in Aggregate Award Group 3. Given that the

1 services must be performed commencing in December of 2016 in order to ensure there is  
2 no lapse of trash removal services at the District locations in Aggregate Award Group 3,  
3 the District must act immediately.

4 (c) Contract No. DCAM-16-NC-0105C is a multi-year contract that requires  
5 Council approval pursuant to section 451(c) of the District of Columbia Home Rule Act,  
6 approved December 24, 1973 (87 Stat. 803; D.C. Official Code §1-204.51(c)) and section  
7 202(b) of the Procurement Practices Reform Act of 2010, effective April 8, 2011 (D.C.  
8 Law 18-371; D.C. Official Code § 2-352.02(b)).

9 Sec. 3. The Council of the District of Columbia determines that the  
10 circumstances enumerated in section 2 constitute emergency circumstances making it  
11 necessary that the Proposed Multiyear Contract No. DCAM-16-NC-0105C Aggregate  
12 Award Group 3 Approval Emergency Act of 2016 be adopted after a single reading.

13 Sec. 4. This resolution shall take effect immediately.
