Yasmine Arrington is the founder of the non-profit organization, ScholarCHIPS and a current member of the Commission on Re-Entry and Returning Citizen Affairs.

In 2010, while a junior in high school, Ms. Arrington founded ScholarCHIPS, an organization that provides college scholarships and mentoring to graduating high school seniors who have a parent(s) in prison, and are pursuing a college education. To date, ScholarCHIPS has awarded over \$80,000 in college scholarships to 23 students. Ms. Arrington has been featured in Teen Vogue, Essence, Black Enterprise and Forbes Magazine; and appeared

numerous times in the Washington Post for her community work. .

A Ward 4 resident, Ms. Arrington received a Bachelor of Arts in Strategic Communications and History from Elon University and is currently pursuing a Master of Divinity from Howard University.
