RESOLVED, BY THE COUNCIL OF THE DISTRICT OF COLUMBIA, That this resolution may be cited as the "Board of Directors of the Washington Metropolitan Area Transit Authority Jeff Marootian Confirmation Emergency Approval Resolution of 2017". Sec. 2. The Council of the District of Columbia confirms the appointment of: Mr. Jeff Marootian 1623 6th Street NW Washington, DC 20001 (Ward 6) as an alternate member of the Board of Directors of the Washington Metropolitan Area Transit Authority, pursuant to section 5(a) of the Washington Metropolitan Area Transit Authority Compact Approval Act, approved November 6, 1966 (80 Stat. 1324; D.C. Official Code § 9-1107.01), and the Washington Metropolitan Area Transit Authority Board of Directors Act,

### Jeff Marootian



Jeff Marootian is the Interim Director of the District Department of Transportation.

Mr. Marootian joined DDOT from the US Department of Transportation, where he served under Transportation Secretary Anthony Foxx from 2013 to 2017. He was appointed by President Barack Obama to serve as the White House Liaison from 2013 to 2015 where he worked alongside the heads of the federal regulatory agencies to promote President Obama's transportation agenda.

In 2015, Mr. Marootian was promoted to serve as the Department's Assistant Secretary for Administration. In that capacity, he oversaw the management functions of the 55,000-employee agency including human resources, facilities, procurement, and security. He was also the Department's Chief Sustainability Officer. Mr. Marootian previously worked at DDOT from 2008 through 2011 as the Customer Service Officer, responsible for public engagement activities and relationships with Advisory Neighborhood Commissioners and other city officials. He also was a Capital City Fellow at DDOT in 2004.

A Ward 6 resident, Mr. Marootian received a Bachelor of Arts and Master of Public Administration from George Washington University.
