Dear Chairman Mendelson:

In accordance with the provisions of D.C. Official Code §1-204.51(c)(3), I am forwarding to you a negotiated First Amendment to the Employment Agreement between Board of Trustees of the University of the District of Columbia and Mr. Ronald F. Mason, Jr, which modifies certain terms and conditions of the existing employment agreement, including extending the term of Mr. Mason's appointment as President through June 30, 2023.

An Emergency Declaration entitled "First Amendment to Employment Agreement of Mr. Ronald F. Mason, Jr., as President of the University of the District of Columbia Emergency Declaration Resolution of 2018" and an Emergency Resolution entitled "First Amendment to Employment Agreement of Mr. Ronald F. Mason, Jr. as President of the University of the District of Columbia Emergency Approval Resolution of 2018" are attached for consideration and enactment by the Council of the District of Columbia.

This emergency legislation will authorize the modification of certain terms and conditions of the employment agreement with the President of the University of the District of Columbia, from an effective date of July 1, 2018 through June 30, 2023. The approval of this emergency legislation will ensure continuity, responsible governance, and a strong students-first focus as we continue to implement our Equity Imperative strategic plan.

Also attached are: (1) the September 26, 2018 UDC Resolution No. 2018-28; (2) a Fiscal Impact Statement from the University's Chief Financial Officer; (3) a Legal Sufficiency Statement and (4) a copy of the First Amendment to the Employment Agreement.

## IN THE COUNCIL OF THE DISTRICT OF COLUMBIA

To declare the existence of an emergency with respect to the need to approve the First Amendment to Employment Agreement between the Board of Trustees of the University of the District of Columbia and Mr. Ronald F. Mason, Jr., as President of the University of the District of Columbia.

    - Sec. 2. (a) There exists a need to approve the First Amendment to the Employment
- Agreement between the Board of Trustees of the University of the District of Columbia and Mr.
  - Ronald F. Mason, Jr., as President of the University of the District of Columbia.
  - (b) The First Amendment to Employment Agreement ensures continuity, responsible
    - governance, and a strong students-first focus as the University continues to implement its Equity
  - Imperative strategic plan.

37	Sec. 3. The Council of the District of Columbia determines that the circumstances
38	enumerated in Section 2 constitute emergency circumstances making it necessary that the "First

40	of the District of Columbia Emergency Resolution of 2018" be adopted on an emergency basis.

Sec. 4. This resolution shall take effect immediately.
