RESOLVED, BY THE COUNCIL OF THE DISTRICT OF COLUMBIA, That this resolution may be cited as the "Public Service Commission Willie Phillips Confirmation Resolution of 2018".

Sec. 2. The Council of the District of Columbia confirms the reappointment of:

as a member and appointment as Chairman of the Public Service Commission, in accordance with 8(97) of An Act Making appropriations to provide for the expenses of the government of the District of Columbia for the fiscal year ending June thirtieth, nineteen hundred and fourteen, and for other purposes, approved March 4, 1913 (37 Stat. 995; D.C. 
