

Mr. Foster has twenty-five years of coaching, teaching, and athletic administration experience at the high school, collegiate, and professional level. Mr. Foster currently manages the athletic operations of 115 schools in the 4th-12th grade aligned District athletic program, and has extensive experience in program and facility management, eligibility, budgeting, and operations.

Mr. Foster has a history of inspiring and empowering student-athletes to achieve academic and athletic excellence, develop leadership, and exhibit integrity. Prior to joining DCIAA, Mr. Foster served as Assistant Head Football Coach for Morgan State University, North Carolina Central University, and other local universities. He also promoted health and physical education as Associate Professor in the Department of Kinesiology at Prairie View A&M University.

Mr. Foster has received several distinctions and awards in the athletic field including the Athletic Hall of Fame from Prairie View A&M University and the District of Columbia's own Archbishop Carol High School, Coach of the Year at Washington Catholic Athletic Conference, and championships at the university level.
