hairman Phil Mendelson at the request of the Mayor A PROPOSED RESOLUTION IN THE COUNCIL OF THE DISTRICT OF COLUMBIA To declare the existence of an emergency with respect to the need to approve Modification Nos. 9, 10 and 11 to Contract No. CW46486 with Tandem Conglomerate, LLC to provide mission oriented business integrated services (MOBIS) and to authorize payment for the goods and services received and to be received under that contract. RESOLVED, BY THE COUNCIL OF THE DISTRICT OF COLUMBIA, That this resolution may be cited as the "Modifications to Contract No. CW46486 with Tandem Conglomerate, LLC Approval and Payment Authorization Emergency Declaration Resolution of 2019". Sec. 2. (a) There exists a need to approve Modification Nos. 9, 10 and 11 to Contract No. CW46486 with Tandem Conglomerate, LLC to provide mission oriented business integrated services (MOBIS) and to authorize payment for the goods and services received and to be received under Modification Nos. 9, 10 and 11 to Contract No. CW46486. (b) On September 20, 2018, by Modification No. 9, the Office of Contracting and Procurement ("OCP") exercised a partial option of option year two from September 21, 2018 through December 31, 2018 in the in the not-to-exceed amount of \$950,000.

35	(c) On September 20, 2018, by Modification No. 10, the OCP extended the
36	partial option of option year two from January 1, 2019 through February 28, 2019 within
37	the ceiling of \$950,000.
38	(d) OCP now desires to exercise the remainder of option year two and increase the
39	total not-to-exceed amount for Contract No. CW46486 to \$10 million for the period
40	September 21, 2018 through September 20, 2019.
41	(d) Council approval is necessary since this will increase the contract by more
42	than \$1 million during a 12-month period.
43	(e) Approval is necessary to allow the continuation of these vital services.
44	Without this approval, Tandem Conglomerate, LLC cannot be paid for goods and
45	services provided in excess of \$1 million for the period September 21, 2018 through
46	September 20, 2019.
47	Sec. 3. The Council of the District of Columbia determines that the
48	circumstances enumerated in section 2 constitute emergency circumstances making it
49	necessary that the Modifications to Contract No. CW46486 with Tandem Conglomerate,
50	LLC Approval and Payment Authorization Emergency Act of 2019 be adopted after a
51	single reading.
52	Sec. 4. This resolution shall take effect immediately.
