

A PROPOSED RESOLUTION

IN THE COUNCIL OF THE DISTRICT OF COLUMBIA

To declare the existence of an emergency with respect to the need to approve.
Modification Nos. 25, 26, and 27 to Contract No. CW18948 with Aramark
Correctional Services, LLC to provide management and operation of the food
service program for inmates, and to authorize payment for the goods and services
received and to be received under that contract.

RESOLVED, BY THE COUNCIL OF THE DISTRICT OF COLUMBIA, That
this resolution may be cited as the “Modifications to Contract No. CW18948 with
Aramark Correctional Services, LLC Approval and Payment Authorization Emergency
Declaration Resolution of 2019”.

Sec. 2. (a) There exists a need to approve Modification Nos. 25, 26, and 27 to
Contract No. CW18948 with Aramark Correctional Services, LLC to provide
management and operation of the food service program for inmates, and to authorize
payment for the goods and services received and to be received under Modification Nos.
25, 26, and 27.

(b) On September 29, 2018, the Council approved the Sole Source Extension for
contract number CW18948 with Aramark Correctional Services, LLC (CA 22-0643) for
the period from October 1, 2018 through December 31, 2018.

1 (c) By Modification No. 25, the Office of Contracting and Procurement (“OCP”),
2 on behalf of the Department of Corrections, increased the amount of Contract No.
3 CW18948 by \$641,306.40 for the period from January 1, 2019 through February 28,
4 2019.

5 (d) By Modification No. 26, OCP, on behalf of the Department of Corrections,
6 further increased the amount of Contract No. CW18948 by \$347,048.10 for the period
7 from March 1, 2019 through March 31, 2019.

8 (e) Modification No. 27 is now necessary to increase the amount of Contract No.
9 CW18948 by \$1,869,581.70 for the period from April 1, 2019 through September 14,
10 2019, raising the total contract amount by \$2,857,936.20.

11 (f) Council approval is required by section 451(b) of the District of Columbia
12 Home Rule Act, approved December 24, 1973 (87 Stat. 803; D.C. Official Code § 1-
13 204.51(b)) since these modifications increase the contract to more than \$1,000,000 during
14 a 12-month period.

15 (g) Approval is necessary to allow the continuation of these vital services.
16 Without this approval, Aramark Correctional Services, LLC cannot be paid for goods and
17 services provided in excess of \$1,000,000 for the contract period January 1, 2019 through
18 September 14, 2019.

19 Sec. 3. The Council of the District of Columbia determines that the
20 circumstances enumerated in section 2 constitute emergency circumstances making it
21 necessary that the “Modifications to Contract No. CW18948 with Aramark Correctional
22 Services, LLC Approval and Payment Authorization Emergency Act of 2019” be adopted
23 after a single reading.
