Marla Carroll is a forensic analyst, consult, and trainer in digital and multimedia forensics. She has been qualified as an expert in numerous jurisdictions and frequently testifies in court regarding multimedia evidence.

Formerly with the FBI and Broward Sheriff's Office Laboratories, Marla is currently the Chair of the American Academy of Forensic Sciences Digital and Multimedia section.

Ms. Carroll has provided instruction for the U.S. Department of State Anti-Terrorism Assistance Program throughout the world, and for law enforcement agencies across the United States and Canada. She was recognized as the first woman instructor for the U.S. State Department of Anti-Terrorism Assistance Program in 2011 as well as recognition as the first woman qualified as a

forensic video examiner by the FBI.
