IN THE COUNCIL OF THE DISTRICT OF COLUMBIA

To declare the existence of an emergency, due to congressional review, with respect to

the need to expand the standby guardianship law to enable a parent, legal guardian, or legal custodian who is, or may be subject to an adverse immigration action, to make short-term plans for a child without terminating or limiting that person's parental or custodial rights.

A PROPOSED RESOLUTION

RESOLVED, BY THE COUNCIL OF THE DISTRICT OF COLUMBIA, That this resolution may be cited as the "Standby Guardian Congressional Review Emergency Declaration Resolution of 2019".

- Sec. 2. (a) According to the American Immigration Council:
- (1) 25,000 undocumented immigrants comprised 26 percent of the
- immigrant population and 3.9 percent of the District's total population in 2014;
 - (2) 23,979 people in the District, including 8,912 born in the United
- States, lived with at least one undocumented family member between 2010 and 2014 and
- (3) During the same period, 7 percent of children in the District were
- United States citizens living with at least one undocumented family member (7,572
 - children in total).
 - (b) The President has made immigration detention and deportation a signature
- issue of his administration and despite the District's designation as a sanctuary city, there
 - continue to be apprehensions and detainments, including inside the DC Superior Court.

1	(c) Over the last year organizations that work with detained individuals in DC
2	have seen a 40% increase in the number of DC residents being held in immigration
3	detention centers.
4	(d) On June 17, 2019, President Donald Trump tweeted: "Next week ICE will
5	begin the process of removing the millions of illegal aliens who have illicitly found their
6	way into the United States. They will be removed as fast as they come in."
7	(e) According to ABC news, on June 18, 2019, an official from the President's
8	administration said that enforcing final deportation orders "is a top priority."
9	(f) On the evening of June 22, 2019, the U.S. Immigration and Customs
10	Enforcement (ICE) performed raids in Adams Morgan and Columbia Heights. ICE
11	visited several restaurants undercover to scope them out, gain access to the back of the
12	kitchen, and interrogate workers. In connection to these raids, two parents that are DC
13	residents were detained by ICE and are being held in a local detention center.
14	(g) On June 25, 2019, there was an additional ICE raid at the Mount Pleasant
15	Library.
16	(h) When District residents are apprehended and detained, they are transported to
17	detention centers outside of the District, as the District does not have any immigrant
18	detention centers within its jurisdiction. It can often take many days for family members
19	to learn about the whereabouts of the detained residents.
20	(i) Emergency legislation is necessary to prevent a gap in the law as the:
21	(1) The previously approved "Standby Guardian Emergency Amendment
22	Act of 2019", effective July 9, 2019, is set to expire on October 29, 2019;

1	(2) The corresponding permanent legislation, B22-402, the "Standby
2	Guardian Amendment Act of 2019", is currently under Council Review with no projected
3	date to become law; and
4	(3) The corresponding temporary legislation, B22-385, "Standby Guardian
5	Temporary Amendment Act of 2019", is currently under Mayoral Review with no
6	projected date to become law.
7	(j) There exists an immediate need for the District of Columbia ("District") to
8	enact legislation to extend the standby guardianship laws to enable a parent, legal
9	guardian, or legal custodian to be able to make plans to protect the wellbeing of their
10	children in advance of an adverse immigration action.
11	Sec. 3. The Council of the District of Columbia determines that the circumstances
12	enumerated in section 2 constitute emergency circumstances making it necessary that the
13	Standby Guardian Congressional Review Emergency Amendment Act of 2019 be
14	adopted after a single reading.
15	Sec. 4. This resolution shall take effect immediately.
