23 IN THE COUNCIL OF THE DISTRICT OF COLUMBIA

28 To declare the existence of an emergency, with respect to the need to amend the District of
29 Columbia Comprehensive Merit Personnel Act of 1978 to change the legal holiday
30 celebrated on the 2nd Monday in October from Columbus Day to Indigenous Peoples'
31 Day; and to amend sections 25-723 and 28-2701 of the District of Columbia Official
32 Code to do the same.

33
34 BE IT ENACTED BY THE COUNCIL OF THE DISTRICT OF COLUMBIA, That this
35 act may be cited as the "Indigenous Peoples' Day Emergency Declaration Resolution of 2019".

37 Sec. 2. (a) Columbus Day was officially designated a federal holiday in 1937, although
38 Christopher Columbus did not discover the Americas, as millions of people were already living
39 in North America upon his arrival in the Americas.

40 (b) Christopher Columbus never set foot on the shores of what is now known as the
41 United States of America.

42 (c) Christopher Columbus enslaved, colonized, mutilated, and massacred thousands of
43 Indigenous People in the Americas.

44 (d) Currently 7 states and more than 70 cities do not observe Columbus Day.

45 (e) Columbus Day is in reverence to a divisive figure whose actions against Indigenous
46 People run counter to the values of equality, diversity, and inclusion—values that the District of
47 Columbia has long embodied—and serves only to perpetuate hate and oppression, in contrast to
48 the values the District espouses on a daily basis.

49 (f) The Council acknowledges the negative historic and continuing impacts of European
50 colonization on the Indigenous Peoples of the Americas and reaffirms the District’s commitment
51 to equality, diversity, and inclusion for all.

52 (g) As part of that commitment, the Council declares that there exists an immediate need
53 to honor Indigenous Peoples’ rich history and culture by acting expeditiously to amend existing
54 law to rename the holiday celebrated on the 2nd Monday in October from Columbus Day to
55 Indigenous Peoples’ Day.

56 Sec. 3. The Council of the District of Columbia determines that the circumstances
57 enumerated in section 2 constitute emergency circumstances making it necessary that the
58 Indigenous Peoples’ Day Emergency Amendment Act of 2019 be adopted after a single reading.

59 Sec. 4. This resolution shall take effect immediately.
