To confirm the reappointment of Mr. Philip McNamara to the Homeland Security Commission. RESOLVED, BY THE COUNCIL OF THE DISTRICT OF COLUMBIA, That this resolution may be cited as the "Homeland Security Commission Philip McNamara Confirmation Resolution of 2019". Sec. 2. The Council of the District of Columbia confirms the reappointment of: Mr. Philip McNamara 3104 16th Street NW, Apt B Washington, DC 20010 (Ward 1) as a member of the Homeland Security Commission, pursuant to section 202 of the Homeland Security, Risk Reduction, and Preparedness Amendment Act of 2006, effective March 14, 2007 (D.C. Law 16-262; D.C. Official Code § 7-2271.02), for a term to end February 22, 2022. Sec. 3.
