

- Analyzes findings and conclusions based on investigation and establishes proof and validity of findings, verifies facts and findings which may serve as a basis for further actions by other agencies which may have a responsibility for terminating or adjusting public assistance grants.
- Acts as a "Special Process Server" in locating and serving summons on alleged parents involved in disputed cases. These summonses are served by the incumbent at any time and any place during regular tours of duty and often at night or on weekends.

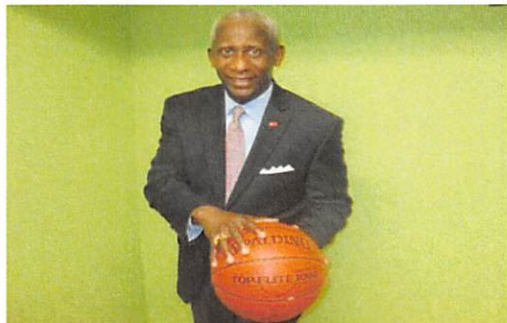
