

Ms. Noor Mir has worked in a civil rights litigation firm, focusing on gender and race discrimination in both individual and class litigation cases, shortly afterwards joining CODEPINK: Women for Peace as an anti-drone campaigner. Here, she focused on coalition building with survivors and their families from Yemen and Pakistan.

Ms. Mir worked as the campaigner for police accountability, criminal justice and ending gun violence at human rights organization Amnesty International. She is currently a partner at the collective DC Action Lab, working with national and local organizations on trainings, long-term strategy and mass mobilizations. She currently serves as a Board Director for Collective Action for Safe Spaces, and was a former board member at the Washington Peace Center.
