Chairman Phil Mendelson at the request of the Mayor A PROPOSED RESOLUTION IN THE COUNCIL OF THE DISTRICT OF COLUMBIA To declare the existence of an emergency with respect to the need to approve Modification Nos. 2 and 3 to Contract No. CW67691 with Keefe Commissary Network, LLC to provide commissary services for District inmates and to authorize payment for the goods and services received and to be received under that contract. RESOLVED, BY THE COUNCIL OF THE DISTRICT OF COLUMBIA, That this resolution may be cited as the "Modifications Nos. 2 and 3 to Contract No. CW67691 with Keefe Commissary Network, LLC Approval and Payment Authorization Emergency Declaration Resolution of 2019". Sec. 2. (a) There exists a need to approve Modification Nos. 2 and 3 to Contract No. CW67691 with Keefe Commissary Network, LLC to provide commissary services for District inmates and to authorize payment for the goods and services received and to be received under Modification Nos. 2 and 3 to Contract No. CW67691. (b) On September 10, 2019, by Modification No. 2, the Office of Contracting and Procurement ("OCP"), on behalf of the Department of Corrections, exercised a partial option of option year one from October 1, 2019 through March 31, 2020 in the in the not-to-exceed amount of \$1 million.

- 1 (c) OCP now desires to exercise the remainder of option year one and increase
- 2 the total not-to-exceed amount for Contract No. CW67691 to \$2 million for the period
- 3 October 1, 2019 through September 30, 2020.
- 4 (d) Council approval is necessary since this will increase the contract by more
- 5 than \$1 million during a 12-month period.
- 6 (e) Approval is necessary to allow the continuation of these vital services.
- 7 Without this approval, Keefe Commissary Network, LLC cannot be paid for goods and
- 8 services provided in excess of \$1 million for the period October 1, 2019 through
- 9 September 30, 2020.
- Sec. 3. The Council of the District of Columbia determines that the
- circumstances enumerated in section 2 constitute emergency circumstances making it
- necessary that the Modifications Nos. 2 and 3 to Contract No. CW67691 with Keefe
- 13 Commissary Network, LLC Approval and Payment Authorization Emergency Act of
- 14 2019 be adopted after a single reading.
- Sec. 4. This resolution shall take effect immediately.
