## Reference: District of Columbia Department of General Services Letter Contract and Proposed Contract No. DCAM-20-NC-RFP-0001D Contract Number: DCAM-20-NC-RFP-0001D Contractor: RBK Construction, Inc. ("RBK")

Dear Chairman Mendelson:

Enclosed for consideration by the Council of the District of Columbia is proposed emergency legislation, "Contract No. DCAM-20-NC-RFP-0001D Approval and Payment Authorization Emergency Act of 2020", and corresponding emergency declaration, to approve the proposed Contract for Comprehensive City-Wide Landscaping Maintenance and Supplemental Landscaping Services, Group D, Wards 7 & 8 (DCAM-20-NC-RFP-0001D) (the "Contract") between the Department of General Services (the "Department") and RBK Construction, Inc. (the "Contractor") in the not-to-exceed ("NTE") amount of \$2,667,017.00; and, to authorize payment to the Contractor for services received and to be received under the Letter Contract and the proposed Contract.

If approved, the Contract will authorize the Contractor to continue providing all labor, materials, tools, supplies, lifts, equipment, vehicles, transportation to and from all worksites, and all else necessary to successfully provide comprehensive city-wide landscaping maintenance and supplemental landscaping services to include the mowing, mulching, pruning, leaf removal, weeding and such other related services for various District owned and operated Properties in Group D, Wards 7 & 8. Such properties include the District's public schools, municipal buildings, and parks and recreation centers, and such other locations as the Department may direct in an NTE amount of \$2,667,017.00. As the amount of the proposed Contract exceeds \$1 million, Council's approval is required for this action.

This Contract is one of five (5) firm fixed price contracts awarded under a single Request for Proposals ("RFP").

In addition to the Letter Contract and proposed Contract, attached are: (i) a contract summary; (ii) a fiscal certification; (iii) memoranda and/or certifications of legal sufficiency; (iv) a Clean Hands certification for the Contractor; (v) a proposed emergency declaration; and (vi) proposed legislation.

33	Sec. 2 (a) There exists an immediate need to approve Contract for Comprehensive
34	City-Wide Landscaping Maintenance and Supplemental Landscaping Services (DCAM
35	No. DCAM-20-NC-RFP-0001D) (the "Contract"), between the Department of General
36	Services and RBK Construction, Inc., which would increase the aggregate not-to-exceed

1	("NTE") amount of the Contract to \$2,667,017.00 and authorize payment to the
2	Contractor for goods and services received and to be received under the Contract.
3	(b) On May 29, 2020, the Department issued a Letter Contract with a not-to-
4	exceed amount of \$922,339.00. The proposed Contract No. DCAM-20-NC-RFP-0001D,
5	in the aggregate NTE amount of \$2,667,017.00, will definitize and include the previously
6	issued Letter Contact and authorize services for the base period through May 31, 2021.
7	(c) The proposed Contract and incorporated Letter Contract would increase the
8	aggregate NTE amount by \$1,744,678.00, from \$922,339 to \$2,667,017.00, an amount in
9	excess of \$1 million; thus, Council approval of the proposed Contract is required
10	pursuant to section 451 of the District of Columbia Home Rule Act, approved December
11	24, 1973 (87 Stat. 803; D.C. Official Code § 1-204.51).
12	(d) In addition, Council approval of the proposed Contract is necessary to
13	authorize the continuation of comprehensive city-wide landscaping maintenance and
14	supplemental landscaping services and compensate the Contractor for services provided
15	and to be provided under the Letter Contract and proposed Contract.
16	Sec. 3. The Council of the District of Columbia determines that the
17	circumstances enumerated in section 2 constitute emergency circumstances making it
18	necessary that the "Contract No. DCAM-20-NC-RFP-0001D with RBK Construction,
19	Inc. Approval and Payment Authorization Emergency Act of 2020" be adopted after a
20	single reading.
21	Sec. 4. This resolution shall take effect immediately.
