

A PROPOSED RESOLUTION

IN THE COUNCIL OF THE DISTRICT OF COLUMBIA

To approve, on an emergency basis, multiyear Contract No. CW80913 with E-One, Inc. to provide a new foam unit to the Fire and Emergency Medical Services Department.

RESOLVED, BY THE COUNCIL OF THE DISTRICT OF COLUMBIA, That this resolution may be cited as the “Contract No. CW80913 with E-One, Inc. Emergency Approval Resolution of 2020.”

Sec. 2. (a) The Office of Contracting and Procurement, on behalf of the Fire and Emergency Medical Services Department, proposes to enter into multiyear Contract No. CW80913 with E-One, Inc. to provide a new foam unit.

(b) The price for the term of this multiyear contract with E-One, Inc. is \$1,149,659.00. The term will be two years from the date of award.

Sec. 3. Pursuant to section 451(c)(3) of the District of Columbia Home Rule Act, approved December 24, 1973 (87 Stat. 803; Pub. L. 93-198; D.C. Official Code § 1-204.51(c)(3)), the Council approves Contract No. CW80913.

Sec. 4. The Council adopts the fiscal impact statement provided by the Chief Financial Officer as the fiscal impact statement required by section 602(c)(3) of the District of Columbia Home Rule Act, approved December 24, 1973 (87 Stat. 813; Pub. L. 93-198; D.C. Official Code § 1-206.02(c)(3)).

1 Sec. 5. The Secretary to the Council shall transmit a copy of this resolution, upon its
2 adoption, to the Mayor.

3 Sec. 6. This resolution shall take effect immediately.
