Enclosed for consideration and approval by the Council of the District of Columbia is proposed emergency legislation, the "Modifications to Contract No. CW80089 with Anchor Mental Health Association, Inc. Approval and Payment Authorization Emergency Act of 2021" and accompanying declaration resolution, to approve Modification Nos. 12 and 13 to Contract No. CW80089 and approve payment to provide Mental Health Mobile Response Crisis Services to children and youth experiencing severe emotional disturbances fleet maintenance and repair services for the Department of Behavioral Health.

21	authorize payment for the goods and services received and to be received under

24	RESOLVED, BY THE COUNCIL OF THE DISTRICT OF COLUMBIA, That
25	this resolution may be cited as the "Modifications to Contract No. CW80089 with Anchor
26	Mental Health Association, Inc. Approval and Payment Authorization Emergency
27	Declaration Resolution of 2021".
28	Sec. 2. (a) There exists a need to approve Modification Nos. 12 and 13 to
29	Contract No. CW80089 with Anchor Mental Health Association, Inc. to provide Mental
30	Health Mobile Response Crisis Services to children and youth experiencing severe
31	emotional disturbances and to authorize payment for the goods and services received and
32	to be received under Modification Nos. 12 and 13.
33	(b) By Modification No. 12, dated July 20, 2020, the Office of Contracting and
34	Procurement, on behalf of the Department of Behavioral Health, exercised partial Option

1	Year 3 of Contract No. CW80089 with Anchor Mental Health Association, Inc. for the
2	period from July 20, 2020 through December 19, 2020 in the amount of \$987,587.25.
3	(c) Modification No. 13 is now necessary to exercise the remainder of Option
4	Year 3 for the period from December 20, 2020 through July 19, 2021 in the amount of
5	\$1,382,622.15, which will increase the total contract amount for Option Year 3 from
6	\$987,587.25 to \$2,370,209.40.
7	(d) Council approval is required by section 451(b) of the District of Columbia
8	Home Rule Act, approved December 24, 1973 (87 Stat. 803; D.C. Official Code § 1-
9	204.51(b)) since these modifications increase the contract to more than \$1,000,000 during
10	a 12-month period.
11	(e) Approval is necessary to allow the continuation of these vital services.
12	Without this approval, Anchor Mental Health Association, Inc. cannot be paid for goods
13	and services provided in excess of \$1,000,000 for the contract period beginning July 20,
14	2020 through July 19, 2021.
15	Sec. 3. The Council of the District of Columbia determines that the
16	circumstances enumerated in section 2 constitute emergency circumstances making it
17	necessary that the Modifications to Contract No. CW80089 with Anchor Mental Health
18	Association, Inc. Approval and Payment Authorization Emergency Act of 2020 be
19	adopted after a single reading.
20	Sec. 4. This resolution shall take effect immediately.
