

This foundation was founded in the loving memory of Matthew J. Brown, my seven year old son who died from Osteosarcoma on September 8, 2009. The Foundation serves as a resource on Osteosarcoma and other childhood cancers by enhancing awareness, education, advocacy, and providing psychosocial support services to children, their families, and medical personnel so that children are better prepared to cope with cancer and thereby lead happy and productive lives during and after treatment. As President and Co-founder of the Foundation, the responsibilities entail: 1) the creation and establishment of a non-profit, which included filing articles of incorporation in the State of Virginia, filing a tax exempt status form with the IRS for a letter of determination, creating by-laws and other governing board documents, 2) the establishment of a governing board, 3) presiding over all board meetings, 4) interfacing with the public and non-profit associations to seek funding to support the Foundation, 5) planning fund raising events, such as the Mattie Miracle Walk scheduled each Spring, 6) presenting at the local and National levels on childhood cancer and the Foundation, 7) publishing and funding psychosocial research, and 8) managing Foundation programs and initiatives that fall under three core areas: awareness, advocacy, and psychosocial support.

This is a 12-credit program for both pre-master's and post-master's students. Responsibilities included assisting the Program Director, fielding applicant questions, and advising applicants throughout the graduate certificate admissions process.

Assisted counseling graduate students complete and process their applications for the bi-yearly administration of The National Counseling Exam (NCE), which is the exam that qualifies an individual for national counselor certification. Created a listserv to update students about the exam process and procedures. Responsible for administering NBCC Continuing Education Units (CEUs) to mental health professionals in the community who attend Counseling Department sponsored workshops and presentations. Oversaw the administration of NBCC CEUs for professional development events that were co-sponsored with the Art Therapy and the Applied Health Sciences Departments.

Graduate Assistant, (September 1996 to August 2001)

Assisted the Counseling Department's Program Director in preparing the application for the re-accreditation of the University's counseling programs. The Department was seeking re-accreditation from CACREP, which document the standards that all counseling programs must meet in order to get re-accredited. The re-accreditation process occurs every five years. Was instrumental in creating the template for the 500-page document. Wrote program summaries documenting and illustrating Department compliance with each CACREP standard and criteria. An example of the information provided was an overview of course content, compiled data from student evaluations, an evaluation of the quality of student internship placements, an assessment of our Department's research publications, alumni job placement, characteristics of our facility and technology, and aspects of the admissions process. Responsible for the coordination of the CACREP accreditation team visit to the University as well as the University's written response to the items addressed in the accreditation team report.

Involved with formulating and organizing the Department's Program Review, which is a University sponsored assessment of the Counseling and Human Resource Development programs. Planned, coordinated, and oversaw a marketing campaign and an alumni event, with over 300 people in attendance.

Created a program evaluation survey that is administered each May to all graduating counseling students. In addition, results are tabulated each year and shared with faculty and the student body. In order to monitor the evaluation process more effectively, developed a flow chart of the Department's schedule of evaluations. The formulation of this chart is in compliance with our programs' accreditation body, CACREP.

Created and maintained four departmental listservs (faculty, doctoral students, master's students, and alumni). As the list master, responsibilities included answering student questions, posting job announcements, internship opportunities, communications between faculty and students, networking opportunities, announcements of professional development activities, and solidifying connections between alumni and the department.

Doctoral Initiative Coordinator, (May 1999 to August 2000)

Coordinated the application process of converting the Ed.D. program in Counselor Education at the University to a Ph.D. program. This entailed: (1) compiling and analyzing doctoral student admissions data; (2) scanning through major newspapers as well as World Wide Web sites to analyze the requirements sought for jobs in academia from 1997 to 2000; and (3) designing and administering a survey to 37 doctoral programs that were accredited by the CACREP to decipher the demand in the U.S. for Ph.D. programs in Counselor Education. The results of this survey were compiled and shared with all 37 programs as well as provided the University with substantial evidence in support of the Department's application for the conversion of the Ed.D. program to a Ph.D. program in Counseling.

eldercare service use/non-use, general self-efficacy, caregiver self-efficacy, and job satisfaction on the perceived stress levels for employed caregivers of older adults. The study was comprised of 100 caregivers of older adults who were employed at a federal agency in the Washington, DC area. The data was coded, and utilizing SPSS, extensive quantitative analyses were performed. In addition, the qualitative data obtained from in-depth interviews were also analyzed. This was the first empirical study of its kind to assess the relationship between eldercare service use and the employee's level of caregiver stress. This study pioneered new ground, because it was the first study of its kind to be conducted at a federal agency.

Cultured human osteosarcoma cells (MG-63) and exposed this cell line to various growth factors (e.g., epidermal growth factor, fibroblast growth factor, platelet derived growth factor, and transforming growth factor) to assess their effects on the activity of alkaline phosphatase and glucose-6-phosphate dehydrogenase, key enzymes in bone formation and metabolism.
