Calvin Woodland, Jr. is a third generation Washingtonian and CEO of The Calvin Woodland Sr. Foundation, a nonprofit organization that serves underprivileged children in the District of Columbia.

Mr. Woodland lives his life as an example and testament to the importance of support for returning citizens to reintergrate as productive members of society. In 1992, he was granted intervention and enrollment in a drug treatment program, which he considers the first day of his new life as an engaged citizen. Upon his release from detention, Mr. Woodland vowed to never return and to become active in politics as an advocate for the

returning citizens community.

Mr. Woodland has worked as a Resident Manager at Community Hope Foundation and Project Director of the Belmont Recovery Group. He later moved to a career in public service as Assistant Director for Constituent Services, Director of Constituent Services, Deputy Chief of Staff, and Chief of Staff in the office of former Ward 1 Councilmember, the late Jim Graham.

A Ward 1 resident, Mr. Woodland remains an active community organizer and advocate.
