

Dr. Marea is a Nurse-Midwife practicing at Community of Hope in Washington DC, and an Instructor of Midwifery and Women's Health at Georgetown University School of Nursing and Health Studies.

Dr. Marea's clinical practice in midwifery has focused on underserved populations both in the US and abroad, including adolescents, under/un-insured women, immigrants, and low-income communities. Dr. Marea's international work includes volunteering with Doctors Without Borders in South Sudan, and research on the reproductive health of women affected by violent conflict in Guatemala, Sierra Leone, Syria, and Somali-refugees in Kenya.

Dr. Marea's overarching career focus is to reduce disparities in

reproductive health outcomes for vulnerable populations, particularly maternal morbidity and mortality. She seeks to increase the capacity of reproductive health care providers to provide excellent care through interventions to improve and maintain high quality health care services. Her academic training, research experience, and clinical practice as a nurse-midwife provide her an excellent background for understanding the profound challenges faced by vulnerable women and those who care for them.

A Ward 6 resident, Dr. Marea received her Bachelor of Science in Foreign Service from Georgetown University, a Masters in Conflict Resolution from the University of Bradford and a Master of Science in Nursing from Yale University.
