

She creates and leads initiatives to support historically disenfranchised communities that experience health disparities and are disproportionately targeted by unhealthy good beverage and food marketing.

Prior to the Center for Science in the Public Interest, Dr. Nara was the nutrition program director at Terrific Inc. in the District of Columbia. Here, Dr. Nara was responsible for providing nutrition counseling and education for low income, at-risk senior citizens, including the management of chronic diseases and preventative and nutritional care.

Throughout her career, Dr. Nara has developed and managed logistics of project programming, including conducting research with healthcare policy, specifically Medicare clients with chronic conditions. She has served as an instructor and clinical supervisor for the Mid-Atlantic School of Herbal Medicine and presented at conferences on integrative medicine and healthy living.
