
Dear Chairman Mendelson:

A PROPOSED RESOLUTION

IN THE COUNCIL OF THE DISTRICT OF COLUMBIA

To declare the existence of an emergency with respect to the need to approve Modification No. 0002 to Human Care Agreement No. CW100338 with Catholic Charities of the Archdiocese of Washington to provide permanent supportive housing services, and to authorize payment for the goods and services received and to be received under the human care agreement.

RESOLVED, BY THE COUNCIL OF THE DISTRICT OF COLUMBIA, That this resolution may be cited as the "Modification No. 0002 to Human Care Agreement No. CW100338 with Catholic Charities of the Archdiocese of Washington, Inc. Approval and Payment Authorization Emergency Declaration Resolution of 2023".

Sec. 2. (a) There exists an immediate need to approve Modification No. 0002 to Human Care Agreement No. CW100338 with Catholic Charities of the Archdiocese of Washington, Inc. to provide permanent supportive housing services, and to authorize payment for the goods and services received and to be received under the modification.

(b) On July 1, 2022, the Office of Contracting and Procurement, on behalf of the Department of Human Services, executed Human Care Agreement No. CW100338 with Catholic Charities of the Archdiocese of Washington, Inc. for the period from July 1, 2022 through June 30, 2023 in the not-to-exceed amount of \$950,000.

35 (c) Modification No. 0002 is now necessary and will increase the total not-to-exceed  
36 amount for the base period by \$1,057,450.60, which will increase the total not-to-exceed amount  
37 for the base period from \$950,000 to \$2,007,450.60.

38 (d) Under section 451(b)(1) of the District of Columbia Home Rule Act, approved  
39 December 24, 1973 (87 Stat. 803; D.C. Official Code § 1-204.51(b)(1), Council approval is  
40 necessary since the modification will increase the value of the contract to more than \$1 million  
41 during a 12-month period.

42 (e) Approval is necessary to allow the continuation of these vital services. Without  
43 approval, Catholic Charities of the Archdiocese of Washington, Inc. cannot be paid for goods  
44 and services provided in excess of \$1 million for the period July 1, 2022 through June 30, 2023.

45 Sec. 3. The Council of the District of Columbia determines that the circumstances  
46 enumerated in section 2 constitute emergency circumstances making it necessary that the  
47 "Modification No. 0002 to Human Care Agreement No. CW100338 with Catholic Charities of  
48 the Archdiocese of Washington, Inc. Approval and Payment Authorization Emergency Act of  
49 2023" be adopted after a single reading.

50 Sec. 4. This resolution shall take effect immediately.
