## IN THE COUNCIL OF THE DISTRICT OF COLUMBIA

# April 4, 2023

To declare the existence of an emergency with respect to the need to approve Modification Nos. 2, 3, 4, and 5 to Contract No. CW92192 with Advanced Data Processing Inc. d/b/a ADPI to provide financial accountability services for the Fire and Emergency Medical Services Department, and to authorize payment for the goods and services received and to be received under the modifications.

RESOLVED, BY THE COUNCIL OF THE DISTRICT OF COLUMBIA, That this resolution may be cited as the "Modifications to Contract No. CW92192 with Advanced Data Processing Inc. d/b/a ADPI Approval and Payment Authorization Emergency Declaration Resolution of 2023".

- Sec. 2. (a) There exists an immediate need to approve Modification Nos. 2, 3, 4, and 5 to Contract No. CW92192 with Advanced Data Processing Inc. d/b/a ADPI to provide financial accountability services for the Fire and Emergency Medical Services Department and to authorize payment for the goods and services received and to be received under modifications.
- (b) By Modification No. 2, dated September 15, 2022, the Office of Contracting and Procurement, on behalf of the Fire and Emergency Medical Services Department, exercised a partial Option Year One of Contract No. CW92192 for the period from October 1, 2022 through December 31, 2022, in the not-to-exceed amount of \$1.5 million.
- (c) By Modification No. 3, dated December 15, 2022, the Office of Contracting and Procurement, on behalf of the Fire and Emergency Medical Services Department, exercised another partial Option Year One of Contract No. CW92192 for the period from January 1, 2023 through February 15, 2023, in the not-to-exceed amount of \$658,830.
- (d) By Modification No. 4, dated February 15, 2023, the Office of Contracting and Procurement, on behalf of the Fire and Emergency Medical Services Department, exercised another partial Option Year One of Contract No. CW92192 for the period from February 16, 2023 through May 1, 2023, at no cost to the District.
- (e) Modification No. 5 is now necessary to exercise the remaining of Option Year One for the period from May 2, 2023 through September 30, 2023, in the not-to-exceed amount of \$3,544,370, which will increase the total not-to-exceed amount for Option Year One to \$5,703,200.

## ENROLLED ORIGINAL

- (f) Council approval is required by section 451(b) of the District of Columbia Home Rule Act, approved December 24, 1973 (87 Stat. 803; D.C. Official Code § 1-204.51(b)), as these modifications increase the contract to more than \$1 million during a 12-month period.
- (g) Approval is necessary to allow the continuation of these vital services. Without this approval, Advanced Data Processing Inc. d/b/a ADPI cannot be paid for goods and services provided in excess of \$1 million for the contract period beginning October 1, 2022 through September 30, 2023.
- Sec. 3. The Council determines that the circumstances enumerated in section 2 constitute emergency circumstances making it necessary that the Modifications to Contract No. CW92192 with Advanced Data Processing, Inc. d/b/a ADPI Approval and Payment Authorization Emergency Act of 2023 be adopted after a single reading.
  - Sec. 4. This resolution shall take effect immediately.
