Enclosed for consideration and approval by the Council of the District of Columbia is proposed emergency resolution, the "Contract No. DCKA-2022-C-0071 with American Traffic Solutions, Inc. d/b/a Verra Mobility Emergency Approval Resolution of 2023", to approve multiyear Contract No. DCKA-2022-C-0071 to provide to provide leased portable and stationary traffic enforcement systems. The term of this contract is two years from the date of award at a not-to-exceed price of \$27,228,000.

Council approval is required by section 451(c)(3) of the District of Columbia Home Rule Act, approved December 24, 1973, 87 Stat. 803, Pub. L. 93-198; D.C. Official Code § 1-204.51(c)(3). Approval is necessary to allow the District to receive these vital goods and services, and the critical requirements of the District can only be met through an award of the proposed multiyear contract to American Traffic Solutions, Inc. d/b/a Verra Mobility.



A PROPOSED RESOLUTION

IN THE COUNCIL OF THE DISTRICT OF COLUMBIA

To approve, on an emergency basis, multiyear Contract No. DCKA-2022-C-0071 with American Traffic Solutions, Inc. d/b/a Verra Mobility to provide leased portable and stationary traffic enforcement systems.

RESOLVED, BY THE COUNCIL OF THE DISTRICT OF COLUMBIA, That this resolution may be cited as the “Contract No. DCKA-2022-C-0071 with American Traffic Solutions, Inc. d/b/a Verra Mobility Emergency Approval Resolution of 2023.”

Sec. 2. (a) The Office of Contracting and Procurement, on behalf of the District Department of Transportation, proposes to enter into a multiyear contract with American Traffic Solutions, Inc. d/b/a Verra Mobility to provide leased portable and stationary traffic enforcement systems.

(b) The not-to-exceed price for the term of this multiyear contract with American Traffic Solutions, Inc. d/b/a Verra Mobility is \$27,228,000. The term will be two years from the date of award.

Sec. 3. Pursuant to section 451(c)(3) of the District of Columbia Home Rule Act, approved December 24, 1973 (87 Stat. 803; Pub. L. 93-198; D.C. Official Code § 1-204.51(c)(3)), and section 202 of the Procurement Practices Reform Act of 2010, effective April 8, 2011 (D.C. Law 18- 371; D.C. Official Code § 2-352.02), the Council approves Contract No.

33 DCKA-2022-C-0071 with American Traffic Solutions, Inc. d/b/a Verra Mobility to provide
34 leased portable and stationary traffic enforcement systems for a two-year period from the date of
35 the award in the not-to-exceed amount of \$27,228,000 for the goods and services to be received
36 under the contract.

37 Sec. 4. The Council adopts the fiscal impact statement provided by the Chief Financial
38 Officer as the fiscal impact statement required by section 602(c)(3) of the District of Columbia
39 Home Rule Act, approved December 24, 1973 (87 Stat. 813; Pub. L. 93-198; D.C. Official Code
40 § 1-206.02(c)(3)).

41 Sec. 5. The Secretary to the Council shall transmit a copy of this resolution, upon its
42 adoption, to the Mayor.

43 Sec. 6. This resolution shall take effect immediately.
