Dear Chairman Mendelson:

Pursuant to section 451 of the District of Columbia Home Rule Act (D.C. Official Code § 1-204.51) and section 202 of the Procurement Practices Reform Act of 2010 (D.C. Official Code § 2-352.02), enclosed for consideration and approval by the Council of the District of Columbia is proposed Multi-year contract CW104839 with Motiv Power Systems, Inc. (Motiv) Emergency Approval Resolution of 2023," and accompanying emergency declaration. The proposed contract is in the \$4,694,850 for the period of 24 months from date of the award.

Under the proposed contract, Motiv shall provide 15 Type-A electric school buses according to the United States Environmental Protection Agency Clean School Bus (CSB) Rebate Program.

24	Sec. 2. (a) The Office of Contracting and Procurement, on behalf of the Office of the
25	State Superintendent of Education, proposes to enter into a multiyear contract with Motiv Power
26	Systems, Inc. to provide electric school buses as part of the Environmental Protection
27	Agency's 2022 Clean School Bus Rebate Program.
28	(b) The not-to-exceed price for the term of this multiyear contract with Motiv
29	Power Systems, Inc. is \$4,694,850 for the two-year period of performance.
30	(c) Approval is necessary to allow the District to receive the benefit of this vital
31	service in a timely manner from with Motiv Power Systems, Inc.
32	(d) These critical services can only be obtained through an award of the
33	multiyear contract with Motiv Power Systems, Inc.

Sec 3. The Council of the District of Columbia determines that the circumstances
enumerated in section 2 constitute emergency circumstances making it necessary that the
"Contract No. CW104839 with Motiv Power Systems, Inc. Emergency Approval Resolution of
