At the Department of Corrections, she is a part of a multi-disciplinary team that identifies medical conditions in inmates within the jail. She also treats inmates with physical therapy needs. At J.A.W. Therapy, Ms. Hagona-Wordie

provides physical therapy management consulting and physical therapy services.

Throughout her career, Ms. Hagona-Wordie has provided physical therapy services in out-patient and homecare.
