Juanita Price is the Chief Executive Officer of the Hillcrest Children and Family Center located in Washington, D.C. The Hillcrest Children and Family Center recently celebrated its 200th Anniversary of serving communities in the District of Columbia.

Prior to her current role at the Hillcrest Children and Family Center, she was appointed to lead the Toledo Mental Health Center, one of the nation's largest urban mental health centers. Beyond treatment of psychiatric patients, the Center sought to establish policy to address patient consent to treatment.

Juanita Price was also appointed to lead the District of Columbia Community Services Agency which provided outpatient behavioral health services to residents.

A Ward 5 resident, Mrs. Price has achieved a Bachelor's Degree in Education from the University of Pittsburgh, as well as a Master of Education degree with a concentration in Administration and Supervision from the University of Toledo.
