Dear Chairman Mendelson:

Today, I am transmitting to the Council of the District of Columbia for its consideration and approval the Medical Cannabis Patient Card Extension 4/20 Medical Cannabis Sales Tax Holiday Week Emergency Amendment Act of 2024 and accompanying declaration resolution and temporary bill. The bill has a three-fold purpose. It amends DC Official Code Title 7 to 1) make District resident-qualifying patient and caregiver registration identification cards valid for six (6) years, 2) give emergency closure authority to the Alcoholic Beverage and Cannabis Administration, and 3) extend the existing medical cannabis tax holiday for an additional four (4) days for 2024 only.

The resolution and accompanying emergency and temporary bill seek to reduce the burden on District residents, including our older patient population with serious health conditions, who may have difficulty navigating the registration process. This change serves to improve patient access into our medical cannabis program and would make the District consistent with the state of Maryland which implemented a six (6) year medical cannabis patient card in 2022.

Additionally, the bill authorizes the Alcoholic Beverage and Cannabis Administration to summarily close an unlicensed retailer where the continued operations of the unlicensed retailer presents an imminent danger to the health, safety, or welfare of the public. Lastly, the bill further supports the industry by temporarily removing the sales tax liability for purchases made during the annual and now expanded Medical Cannabis Tax Holiday.

For the reasons discussed above, I urge the Council to take prompt and favorable action on the enclosed proposed bill.

15	To declare the existence of an emergency with respect to the need to amend the Legalization of
16 17	Marijuana for Medical Treatment Initiative of 1999 to set a new expiration date for qualifying patient and caregiver registration identification cards from two years to six
18	years, and to require the surrender of a registration card (and notification of any
19	registered caregiver) when a person no longer requires medical cannabis; to authorize the

27	Sec. 2. (a) To address the burdens associated with becoming a registered medical
28	cannabis patient and provide relief to struggling lawfully operating medical cannabis
29	dispensaries, the Council previously adopted legislation allowing patients with expired
30	registration identification cards to continue purchasing medical cannabis for a short period of
31	time and establishing two-year registration identification cards for new patients.
32	(b) There remains a need to further reduce the administrative barriers for District
33	residents seeking to access quality medical cannabis and medical cannabis products at licensed
34	dispensaries. There are currently 1,850 District resident patient registrations set to expire during
35	the three-month period of March 2024 through May 2024; where those residents do not renew

36 their patient registrations due to real or perceived administrative burdens, they may be inclined to 37 utilize the more than 220 unlicensed cannabis establishments located in the District. Recent testing by the Metropolitan Police Department at several of these unlicensed establishments 38 39 uncovered synthetic cannabis for sale that tested positive for amphetamines. Extending the 40 validity of patients' and caregivers' registration cards to six years, from the current two years, 41 will encourage residents to continue to utilize the District's licensed dispensaries to purchase 42 medical cannabis and medical cannabis products. Furthermore, extending the length of time that 43 a medical cannabis patient registration identification is valid to six years will bring the District in 44 line with Maryland, which transitioned to a six-year medical cannabis patient card on September 45 29, 2022.

46 (c) Based on ongoing investigations, the Alcoholic Beverage and Cannabis 47 Administration believes there are approximately 200 unlicensed marijuana retailers operating in 48 the District. On March 27, 2024, a robbery and fatal shooting occurred at an unlicensed retail 49 store on Georgia Avenue. The significant clustering of unlicensed marijuana retail stores along 50 commercial corridors presents an ongoing threat to the health and safety of residents, has an 51 adverse impact on the viability and safety of our commercial corridors, and undermines the 52 financial viability of cannabis establishments that are in compliance with District law and 53 regulations. To respond to the threat posed by the unlicensed retailers, ABCA needs clear 54 statutory authority to summarily close those businesses and seize any marijuana contraband. 55 (d) In February 2022, the Council adopted emergency legislation creating the District's inaugural "4/20 Medical Cannabis Sales Tax Holiday Week." During this tax holiday, medical 56 cannabis patients were exempt from paying the 6% sales tax period for a 10-day period, which 57 58 included two weekends. The holiday was quite successful with consumers and lawfully operating

59 medical cannabis dispensaries in the District. This emergency legislation seeks to reinstate this 50 successful tax holiday week again in 2024 during the two-week period of April 15, 2024 through 61 April 28, 2024, which would, again, cover two weekends. The popular "4/20 Medical Cannabis 62 Sales Tax Holiday Week" is critical to the District's efforts to attract qualifying patients back to 63 the legal market as well as sustain a viable medical cannabis program.

- 64 Sec. 3. The Council of the District of Columbia determines that the circumstances in
- 65 section 2 constitute emergency circumstances making it necessary that the Medical Cannabis
- 66 Patient Card Extension and 4/20 Medical Cannabis Sales Tax Holiday Week Emergency
- 67 Amendment Act of 2024 be adopted after a single reading.
- 68 Sec. 4. This resolution shall take effect immediately.
