

A PROPOSED RESOLUTION

IN THE COUNCIL OF THE DISTRICT OF COLUMBIA

To declare the existence of an emergency with respect to the need to approve multiyear Contract No. DCAM-24-NC-CA-0005 with WGL Energy Services, Inc. to provide firm and interruptible natural gas supply for the District's real estate portfolio.

RESOLVED, BY THE COUNCIL OF THE DISTRICT OF COLUMBIA, That this resolution may be cited as the "Multiyear Contract No. DCAM-24-NC-CA-0005 with WGL Energy Services, Inc., Emergency Declaration Resolution of 2024".

Sec. 2. (a) The Department of General Services proposes to enter into a multiyear contract with WGL Energy Services, Inc., to provide firm and interruptible natural gas supply to the District's real estate portfolio.

(b) The not-to-exceed amount of this multiyear contract with WGL Energy Services, Inc., is \$18,275,000. The period of performance is from June 1, 2024, through June 30, 2027.

(c) Approval on an emergency basis is necessary to allow the District to receive the benefit of locking in favorable pricing against price volatility in the energy market, lowering the overall energy cost over the subsequent thirty-seven (37)-month period.

34 Sec. 3. The Council of the District of Columbia determines that the circumstances
35 enumerated in section 2 constitute emergency circumstances making it necessary that the
36 Multiyear Contract No. DCAM-24-NC-CA-0005 with WGL Energy Services, Inc.,
37 Emergency Approval Resolution of 2024 be adopted after a single reading.

38 Sec. 4. This resolution shall take effect immediately.
