Professional Experience:

Planning Director Montgomery County Planning Department Maryland-National Capital Park and Planning Commission 2013 – 2022

Oversaw all planning and development review activities in Montgomery County, the largest jurisdiction in Maryland with over 1 million residents. In this time, the Planning Department completed a major rewrite of the county zoning code, over 24 transformative master plans in communities such as Downtown Bethesda, Downtown Silver Spring, White Oak, Westbard and Grosvenor, and an update to the county's general plan. The Planning Department also implemented a Design Excellence initiative, which led to great improvement in the quality of design for projects throughout the county – including the new M-NCPPC Headquarters in Wheaton. Ms. Wright is a graduate of ULI Washington's Regional Leadership Institute and served on ULI Washington's Advisory Board. She is a member of the Technical Advisory Committee for the University of Maryland Urban Studies and Planning Program, is a former co-chair of the COG Planning Directors Technical Advisory Committee and received the Potomac Valley Chapter of the AIA's Kea Medal for Architectural Advocacy.

Chief, Development Division Department of Planning and Zoning City of Alexandria, Virginia 2008 to 2013

Managed the City's regulatory review process for all new projects, including major new mixed-used and transit-oriented developments such as Potomac Yard. Supervised the Development Division and assured that the development process was as effective and efficient as possible.

Acting Director Montgomery County Planning Department Maryland-National Capital Park and Planning Commission 2007 to 2008

Oversaw the Montgomery County Planning Department with responsibility for producing master plans, managing a major regulatory program, undertaking research and demographic studies, and coordinating transportation, environmental and historic preservation activities.

Chief, Countywide Planning Division Montgomery County Planning Department Maryland-National Capital Park and Planning Commission 2006 to 2008

Managed the Countywide Planning Division, which included nearly 50 professionals in the fields of transportation, environmental and historic preservation planning. Provided technical input into master plans and regulatory cases, administered the Forest Conservation Program, administered the Historic Preservation program, and provided support to the Historic Preservation Commission.

Historic Preservation Supervisor Montgomery County Planning Department Maryland-National Capital Park and Planning Commission 1991 to 2006

Administered the historic preservation program for Montgomery County, Maryland's twenty historic districts and 400 individual landmark sites. Provided technical support to the Historic Preservation Commission, Planning Board, and County Council on historic preservation issues; coordinated the evaluation and designation of historic sites and districts, design review of alterations to designated properties, administration of a preservation grant program and a property tax credit program for historic sites, and production of educational materials and events on preservation topics.

Historic Preservation Planner Montgomery County Planning Department Maryland-National Capital Park and Planning Commission Montgomery County, Maryland...1987 to 1991

Provided technical support to the Montgomery County Planning Board on historic preservation issues, including: the evaluation and designation of historic sites and districts; the impact of proposed site plans, subdivisions, and development projects on designated and potential historic resources; the impact of proposed road projects on historic resources; and the development of legislation regarding preservation programs.

Director of Architectural Design and Redevelopment Galveston Historical Foundation (GHF) Galveston, Texas...1979 to 1987

Coordinated a vigorous commercial and residential revitalization effort which included managing a Residential Revolving Fund, design review on nearly 40 facade easements and deed restrictions held by GHF, development and implementation of a major proposal to create a locally-zoned historic district in the Strand National Landmark area, supervision of extensive rehab advice and education services, and close coordination with City planning staff on zoning and planning issues.

Gwen Wright



Ms. Gwen Wright is a longtime District resident and a former Montgomery County Planning Director. She served on the Montgomery County Planning Board for 30 years and is one of the longest tenured directors in the history of the Maryland-National Capital Park and Planning Commission.

While Planning Director, she completed a record number of master plans in Bethesda, Silver Spring, Grosvenor, Rock Spring, Montgomery Village, Westbard, Lyttonsville, White Flint II, and Chevy Chase Lake. She was also responsible for or contributed to many of the Commission's most notable accomplishments during her tenure, including the Legacy

Open Space Program, Montgomery County Heritage Tourism Program, Montgomery County's Historic Preservation Program, acquisition of key historic properties, the 2017 Bethesda Downtown Plan, Thrive Montgomery 2050, the Design Excellence Program, and the initiation of the Commission's Placemaking Program. In 2017, she was awarded the American Institute of Architects Potomac Valley awarded her the chapter's highest honor, the Paul H. Kea Medal, in recognition of her advocacy of design in establishing the Design Excellence Program. After her departure, the Mongomery Planning Board named the Montgomery County Award for Design Excellence in her honor.

Ms. Wright previously served as Development Division Chief for the City of Alexandria Department of Planning, as well as Director of Architectural Design and Redevelopment for the Galveston Historical Foundation.

A Ward 3 resident, Ms. Wright earned her Bachelor of Arts in Architecture and Architectural History from Yale University.
